AFFIDAVIT OF CHARLES S. RITTENBERG M.D. IN SUPPORT OF DEFENDANT'S OPPOSITION TO PLAINTIFF'S MOTION FOR PRELIMINARY INJUNCTION

PERSONALLY APPEARED BEFORE ME, Charles S. Rittenberg M.D., who being duly sworn deposes and states as follows:

- I am an adult over the age of 18 and am competent to testify about the facts set forth in this affidavit;
- 2. I am a board certified Maternal-Fetal Medicine physician (high risk obstetrician), practicing in South Carolina, and specialize in progesterone for the prevention of recurrent spontaneous preterm birth. I am also an Assistant Professor of Obstetrics and Gynecology at the Medical University of South Carolina. My Curriculum Vitae is attached as Exhibit A to this Affidavit;
- 3. Spontaneous preterm birth is one of the biggest problems in obstetrics today. Spontaneous preterm birth refers to early delivery brought on by preterm labor or premature rupture of the membranes leading to spontaneous labor, rather than a physician's decision to recommend early delivery to improve outcomes for mother or baby;
- 4. In 2003, Meis et al published the results of a National Institutes of Child Health and Human Development sponsored trial that showed 17-alpha hydroxyprogesterone caproate (17P) is efficacious in reducing recurrent spontaneous preterm birth. I have received a grant since March of 2008 from the March of Dimes, for my efforts in promoting the use of 17P for preterm birth prevention. This grant predates the FDA's approval for Makena;

- 5. Through this grant, I have educated health care providers, insurers, and patients about the indications for using progesterone. I have published research on prescribing patterns of 17P in preventing preterm birth, and have concluded that since the Meis publication in 2003, physicians across the United States have been using progesterone at an accelerating rate. At times, 17P has been difficult to get approved by insurers though this has not been much of a problem in South Carolina since about 2008;
- Prior to 2000, 17P was available under the name Delalutin, which was an FDA approved drug, and had been FDA approved since 1956. Doctors have thus been using the drug 17 alpha hydroxyprogesteronecaproate for roughly 60 years;
- After 2000, Delalutin was no longer on the market, for reasons unrelated to safety or effectiveness, and doctors went back to prescribing compounded 17P;
- In 2003, Meis et al published the results of their study undertaken to see if
 17P is effective in reducing recurrent spontaneous preterm delivery;
- 9. The study used a double-blind, placebo-controlled trial involving pregnant women with a documented history of spontaneous preterm delivery. All the participating subjects were women between the 16th and 20th weeks of gestation at the time of enrollment, and were randomly assigned in a two to one ratio to receive either a weekly injection of compounded 17P, or weekly injections of a placebo. These injections continued until the 36th week of gestation;
- The study found that weekly injections of compounded 17P significantlydecreased the rate of recurrent preterm delivery among eligible women, and served to reduce the likelihood of severe complications in infants;
- I began advocating the use of, and actively prescribing, 17P for eligible women in South Carolina beginning in 2005. Through my efforts, I determined that doctors were already using 17P, but had trouble accessing it;
- In my own practice, I found that 17P significantly increased the length of a pregnancy for women who were at high risk for preterm labor;
- 13. Makena became a "covered drug" for South Carolina Medicaid beneficiaries in 2011. Makena has the same formulaic makeup as 17P;
- To date, I have never prescribed Makena for a patient, and have no personal knowledge of another physician prescribing Makena;
 - In my work, I often submit prior authorization requests for prescriptions;
- Prior authorization requests are categorized as pharmaceutical or physician administered. Physician administered requests are sent to DHHS and document the

"medical necessity" for a prescription, and do not deter patient access to certain drugs, nor do they deter physicians from prescribing certain drugs;

- My decision against prescribing Makena has nothing to do with Makena's prior authorization requirement;
- 18. Instead, I prescribe 17P because I have used the compound for years and have data to show its effectiveness among my patients, and have never had reason to doubt the practices of the compounding pharmacies that I have used;
- Makena, as a product, has been the subject of fewer studies to test its safety and efficacy than the compounded 17P;and
- To the best of my knowledge, the FDA has not issued any statement to indicate that 17P is any less effective, or less safe than Makena.
