The Mesquite Symphony Orchestra (MSO) is seeking a passionate and talented Conducting Fellow to join our team. The Conducting Fellow will have the unique opportunity to work closely with our Music & Artistic Director, staff, musicians, and community to develop their skills in orchestral leadership and conducting.

This fellowship goes beyond the podium by including our Conducting Fellows in the artistic and administrative operations of the MSO. Conducting Fellows will gain skills on the podium, music library, boardroom, marketing, artistic planning, concert production, and more.

## **Key Responsibilities**

- 1. Conducting and Rehearsals: Prepare all concert repertoire to the same level as the Music & Artistic Director, to be ready to step in for rehearsals or performances if needed. Assist the Music & Artistic Director in leading rehearsals and performances. This may include conducting portions of rehearsals, running sectional rehearsals, and conducting in concert as assigned depending on experience and preparation. Podium time will include masterclass-type instruction by the Music & Artistic Director in front of the orchestra.
- Mentorship and Training: Participate in professional development opportunities
  provided by the Music & Artistic Director. This may include one-on-one
  mentorship, observing rehearsals and performances, and studying conducting
  techniques.
- Programming and Artistic Administration: As requested, Conducting Fellows
  may assist in the development of concert programs, participate in planning
  meetings, and collaborate in the execution and launch of current and future
  artistic initiatives.

Administrative Support: Participate in various administrative tasks associated
with running an orchestra, including but not limited to score preparation, library
assistance, program note creation and curation, and other logistical support as
needed.

## Qualifications

- 1. Advanced degree (or currently pursuing) in Music with a focus on Orchestral Conducting or equivalent experience.
- 2. Demonstrable experience in conducting an orchestra, such as leading a university ensemble, assistant conducting role, or high school full orchestra.
- 3. Excellent leadership and communication skills, with the ability to effectively work with a wide range of individuals, including professional musicians, staff, and community members.
- 4. Strong knowledge of orchestral repertoire, programming, and concert production.
- 5. Passion for community engagement and education in the arts.
- 6. Flexibility to work evenings and weekends, in line with the orchestra's rehearsal and performance schedule. Schedule will be provided upon request.
