# **Agency Announcements:**

ADVOCAP: ADVOCAP has been awarded a two year, \$854,295 grant from the State of Wisconsin Department of Administration to be used for a Tenant Based Rental Assistance program. TBRA Program funds currently available and ADVOCAP needs referrals. TBRA offers Short term (up to 24 months) rent subsidy similar to Section 8 Housing Choice Vouches to homeless households and those at risk of homelessness with no case management. This program could assist up to 40 households including low barrier household. First come first served. No income minimum. Rapid rehousing grant available for victims of Domestic violence or fleeing Domestic violence. 3 counties. 10 slots served. Up to 2 years with case management. No income minimum.

Oshkosh/Winnebago County Housing Authority (OHA/WCHA): Waiting list closed for Housing Choice Voucher Program, Waite Rug Place and Raulf Place. Back to School Fair will be on 8/15.

**Partnership:** Partnership has 10 slots for Dental Care with 4 dentists on staff. If they do not have insurance, clients can get assistance and partnership can serve anyone. Let me help facilitate healthcare.

<u>City of Oshkosh:</u> City is working on Fair Housing, updating 5 year Consolidated Plan, Public service block program (CDBG), a new shelter for women with AODA issues (collaboration with Reach and Solutions Recovery), and applying for a 1.5-2 million lead based grant.

<u>Day by Day Warming Shelter:</u> Day by Day is providing drop in hours 2 times per week for laundry and showers.

**ECWRPC:** They are updating the region's Long-Range Transportation Plan in 2019-2020 for Fox Cities, FDL and Oshkosh.
