- I. Firstly, I ask the doctor for permission to conduct this test and if he could find a test subject to use for this.
- II. Secondly, the Class-D is brought to the Eps Checkpoint, alongside all security personnel required for the test.
- III. After arriving at Eps, a CSU will brief all participants, pass us through the metal detector and send us to SCP-DO9's Chamber in order to get a sample. (Infecting a Class-D, Tranqualizing him, taking a sample with vials)
- IV. Once we have arrived at the chamber of SCP-009, the Class-D is to be brought to the outer containment for pre-test briefing.
- V. After this is done, all P3MPS / HAZMAT suit users are to enter the outer containment "Circle" while all other participants are to enter the VA.
- VI. Next, the doctor will be asked if he can "Cure" the Class-D of the pestilence, while 049-2 is in the airlock.
- VII. After the now "Cured" 049-2 enters the inner circle, where **SCP-009** is stored, he is to touch the crystal.
- VIII. Once 049-2 touches SCP-009, he is to come to the edge and wait, if he jumps he will be terminated.
- IX. Now I will obtain a sample of the SCP-DO9 affected D49-2 and synthesise it, in turn creating a cure for the SCP-DO9 affected D49-2.
- X. After this is done I will put the cure onto the SCP-DD9 affected D49-2.
- XI. Next, I will ask the doctor whether he would like to keep this "Cured" or if he would like him to be terminated.
- XII. At last, once the test is concluded everyone is to leave Eps and continue normal duties.

<u> Dutcome 🗛</u>

1 A. If the test goes well and the "Shrek" won't be infectious anymore, the doctor has the final decision.

2 A. In case the "Shrek" is still infectious, he is to be terminated along with any personnel that touched him while not wearing a P3MPS / HAZMAT suit.

-[Results]-

Result description/summary:

During the test, SCP-049-2 mutated into a regular SCP-009 instance. There were some more interesting parts but there wasn't anything out of the ordinary. The test generally went well with the doctor also being impressed that one of the side effects was cured.

Theories:

Theory1 was disproven as the SCP-049-2 mutated into a regular SCP-009 instance, having the regular color gradient, just this time going from a green-ish tone to the regular red one. [See EV.1]

Theory2 was again, disproven as when asked if speech was possible (This was done before and after being cured via the 009 cure), the "Shrek" responded by moving sidewards, signaling a no.

Something interesting I found was that the skin color side effect of the affected Class-D / "Shrek" seemed to vanish, as the skin color was returned back to a normal, human one, although the weird posture still remained. [See EV.2]

Another interesting part was that the SCP-009 cure seemed to also revert the strength of the SCP-009 affected "Shrek", this was found out accidentally as the C9 escort asked if the "Shrek" could hit him, which showed that the "Shrek" did moderate damage (not stacking with the strength of SCP-009.

<u>Theory</u>

If the skin-color side effect of the Class-D was cured, could other side effects also be cured? If so, which one could be cured? Which wouldn't be able to be cured?

- b) What effects would transfer over if a Class-D that was exposed to all of this would be stabbed with **SCP-O34**?
- c) How would taking an instance of **SCP-500** affect the user after he was exposed to this? Would **SCP-500** return the user to his first state? Or would **SCP-500** return the user back to the stage where he was infected with **SCP-009** / "Cured"

Theory II:

As the Class-D skin color was able to be changed back to normal by the SCP-009 cure, which also somehow cured the side effect of the SCP-009 cure being that the skin color would stay red, what would happen if the same experiment were to be repeated with SCP-409?

b) Since I suppose that the colors of SCP-009 and SCP-049-2 mixed, would they turn teal? Or would they make the normal skin color?

Theory III:

As the strength of SCP-009 and SCP-049-2 didn't merge, would there be a way to merge their strength?

b) If merging effects were to be possible, how strong could someone be made?

Theory IV:

What would SCP-914 make with this "Shrek"?

- b) Would **SCP-914** be able to make a *new* infection combining the effects of **SCP-009** and SCP-049-2?
- c) Would SCP-914 be able to cure some more side effects? If so, what ones could be cured?

d) How far could **SCP-914** reset effects / scramble them? Would a RS-ish SCP be created if enough "Things" are put into the machine?
