Let's get personal

You may or may not be aware a particularly egregious video appeared about me late last Friday.

The gentleman who did the video is apparently a self-proclaimed 'slayer of the fraudsters.'

And without any modicum of following professional journalist standards and practices he didn't even attempt to contact me to ascertain the validity of his comments.

I wish he had contacted me first to corroborate his story - as a partner, he has my email address.

The attack he made on me was vicious to say the least, he even resorted to calling me names which in my opinion was completely unnecessary, and attacking my character in general.

I have no intention of attacking him in kind, well, that's just not my style.

However I think it important you realize who the real Mike G is and what I stand for.

All of my adult life through my professional and personal life I have worked to serve other people to the best of my ability.

What I'm about to share with you is not a boast, it's just so you understand more about me.

As I began to become exceedingly successful in my real estate career I joined an organization called the Michigan Rental Housing Association. I have never ever shared this story with anyone.

One year in particular the last item out of Santa's bag was a set of keys to a brand new SUV parked in the driveway so mom could reliably get to and from work on her crazy swing shift schedule. Not one of the beneficiaries ever, never, knew where the visit from Santa came from, and I was never anywhere in the vicinity. I was just satisfied to know I was helping in some small way.

I have bought more turkeys for churches than I can recount, in the thousands to distribute to their special list of the needy, and I have purchased more new cars for other families than I can remember.

Also, while juggling all of these philanthropy things I managed to find time to run as a township supervisor, the equivalent of a City Council member but in my township of approx 50,000 residents, again without salary, and was elected twice, two consecutive four year terms, and I received more votes each time than any of the two closest candidates put together.

One year I even donated thirty building sites to Habitat for Humanity free and clear with all real estate taxes paid up to date, for them to build homes on for the needy.

Finally, for years I would purchase literally thousands of small gifts and have them delivered to our local fire department to aid them in their 'Toys for Tots' drive. Funny but I became known by the firemen as 'the toy man' because each year I did this I made our local fire station the number one 'Toys for Tots' collector in the county.

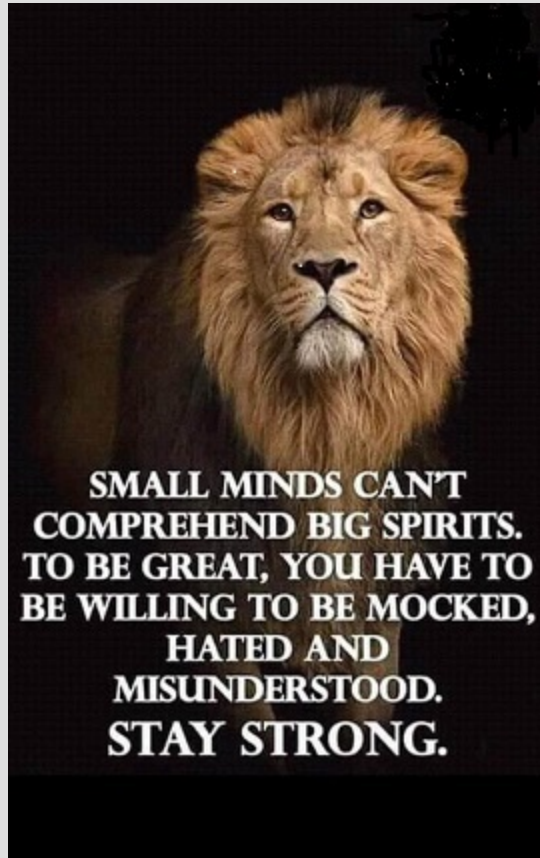

Reserve account

You may recall recently I had a need to replenish my reserve account because I had dipped into it to help a couple people out that were desperate.

In that same paragraph I said please no more loan requests, since I have now replenished my reserve account by the skin of my chin, it's not a fortune but it's just for an emergency for the closing if needed.

Something else I think all my partners need to realize is this...
