



Social Room Bar Disclaimer & Terms and Conditions

In accordance with AGLC regulations, if an individual, organization, or group books the EAD facility with the intent to serve liquor in the Social Room Bar, they are required to obtain their own AGLC License and assume full responsibility for compliance.

Alternatively, if you prefer to have EAD manage the Social Room Bar for your event, we will do so, taking on full responsibility, but this service will incur additional costs.

1. Applicant Prefers to Manage the Social Room Bar Themselves:

a. Liquor License: The Applicant is responsible for obtaining their own AGLC Liquor License at least 4-6 weeks before the event. A copy of this license must be provided to EAD to ensure compliance with all legal requirements. Failure to obtain the license on time may result in the cancellation of the event or other legal consequences.

b. Liquor Purchasing and Sales: The Applicant will purchase and sell liquor through the Handtalk Bar. Any unopened liquor must be returned to the liquor stores after the event. The Applicant retains 100% of the revenue generated from liquor sales at the Social Room Bar, ensuring they maximize their event's profitability.

c. 50/50 License and Raffles: The Applicant is fully responsible for securing their own 50/50 License and managing all aspects of raffle proceeds, door prizes, and admissions. By handling these elements, the Applicant retains full control over and profit from their event's fundraising activities.

d. Bar Operations: The EAD Social Room Bar Director will be responsible for the opening and closing of the Social Room Bar. However, the Applicant must find their own volunteers to staff the bar during the event. The Applicant is also responsible for the behavior and conduct of all attendees, volunteers, and staff during the event, ensuring that the event runs smoothly and adheres to all EAD and AGLC regulations.

e. Rental Fee and Damage Deposit: The Applicant is responsible for paying all applicable rental fees and damage deposits. These payments must be made in accordance with the terms set forth by EAD. The damage deposit will be refunded in accordance with EAD's policies, provided the facility is left in good condition following the event. Failure to meet these financial obligations may result in additional charges or restrictions on future bookings.



2. Applicant Prefers EAD to Manage the Social Room Bar:

EAD operates under its own Private Resale Annual License (Special Event License), which applies to specific, pre-approved event dates.

a. License Restrictions: The EAD License is limited to EAD Members and Invited Guests only. If the Applicant prefers EAD to run the Social Room Bar, they must agree that all event advertising will be managed by EAD and shared exclusively with EAD Members and Invited Guests. This ensures that the event remains compliant with the terms of EAD's license.

b. Liquor and Beverage Management: EAD will take full responsibility for purchasing and managing all liquor and beverages served at the event. All revenue generated from the Social Room Bar during the event will belong to EAD. The Applicant should note that for any event held under EAD's AGLC License, the Social Room Bar is required to generate a minimum gross profit of \$100.00.

c. Profit Minimum and Shortfall Responsibility: If the Social Room Bar does not meet the required \$100.00 minimum gross profit, the Applicant will be responsible for paying the difference. This amount must be paid within 30 days following the event. Failure to settle the difference within this period will result in the Applicant being considered in arrears to EAD. As a consequence, the Applicant will be prohibited from booking or using the EAD Handtalk Bar until all outstanding balances are fully paid.

d. Additional Fundraising Activities: While EAD manages the Social Room Bar, the Applicant remains fully responsible for obtaining their own 50/50 License and overseeing all aspects of raffle proceeds, door prizes, and admission charges. The Applicant retains 100% of the admission revenue and any other fundraising income generated independently of the Social Room Bar.

By opting for EAD to run the Social Room Bar, the Applicant agrees to these terms and ensures that the event operates smoothly and in accordance with EAD's licensing requirements.
