# **Position Summary**

The position of Youth Fire Coordinator for the Wisconsin State Fire Inspectors Association is for the purpose of developing and maintaining public education programs and materials as they pertain to youth fire setters and prevention.

This position will have responsibility for development and maintenance of youth fire setting materials for all association members to help provide uniformity state wide in areas of fire and life safety education trends and programs. Establish good working relationships with curriculum making bodies, other state and national organizations, and most important the members that make up this Association. This position shall work closely with the Community Risk Reduction & Public Education Director of the Association.

### **Fundamental Duties of the Position**

- The development and maintenance of information and training resources related to youth fire setting
- Maintain resources for public education as it pertains to youth fire prevention for members
- Develop, modify, implement, evaluate and prioritize education and outreach programs for use by members

#### **Essential Functions:**

- Must be a member in good standing with the Association
- Be appointed to an indeterminate term by the President and confirmed by a majority vote by the Board of Directors.
- Be a voting member of the Board of Directors
- Have a working knowledge of CCR and public education programs
- Be present at Board meetings, General Business Meetings, or as directed by the President or designee.
- Assist the 1<sup>st</sup> Vice President as a facilitator of the Annual Conference and serve on the Conference Committee
- Takes actions necessary to support the mission statement of the Association.
- Implement all established goals and objectives through cooperative interaction and discussions with and under the direction of the Board of Directors.
- Provide and maintain resource materials to the membership.
- Establish work priorities, work schedules and coordinate work activity with the Board of Directors.
- Promote and provide trainings opportunities to all Association members.
- Perform quality control checks on programs to ensure they meet their stated goals/objectives.
- Develop a standardized method of how programs and educational materials will be housed and where they will be located.
- Assist Area Chairpersons in planning and coordinating fire prevention programs and materials.
- Explore grant opportunities the Association may be eligible for to offset training costs.
- Investigate internet based training opportunities to reduce the costs associated with travel and attendance.
- Assist as an ambassador of the Association when attending other state or national functions.
