This former Los Angeles police officer was accused of sexually assaulting four children. He was charged with eight counts of committing lewd acts on a child. He died under mysterious circumstances after being held on \$2.5 million bail. It was later revealed that Paul had a pre-existing medical condition that worsened while in custody.

Schaefer was convicted of murdering numerous women and even kept their teeth as trophies. He was sentenced to two concurrent life terms. In prison, Schaefer became notorious for being arrogant and an informant. This did not sit well with many inmates, leading them to band together and kill him.

Robert Fratta.

Fratta was found guilty of hiring two individuals to murder his estranged wife amid a bitter divorce and custody dispute. Even though he maintained his innocence, the court upheld its decision. After spending over 30 years on death row, he was administered a lethal injection at the state penitentiary in Huntsville, Texas.

Gennady Mikhasevich.

As a freelance police officer, Mikhasevich was responsible for a series of crimes that wrongly convicted over 14 individuals. From 1971 to 1985, Mikhasevich murdered more than 36 women. Thankfully, with the accumulation of substantial evidence, he was apprehended. He was sentenced to death in 1987, and subsequently, a firing squad executed him.

Anthony John Sully.

This police officer was convicted for the murders of six individuals between February and August 1983 at his warehouse in Burlingame, California. Even though he maintained his innocence, he was sentenced to death. He spent 37 years on death row before passing away from natural causes at the San Quentin Rehabilitation Center.

Florisvaldo de Oliveira.

Florisvaldo de Oliveira, a former military police officer better known as 'Cabo Bruno,' was sentenced to over 100 years in prison for committing more than 50 murders. Despite his lengthy sentence, he was released after serving 27 years. Just 35 days after his release, he was tragically killed while returning from a religious service.

Theodore Dyer.

Following his arrest and conviction on one count of first-degree criminal sexual conduct, Dyer was sentenced to prison. Just 10 months into his 25-to-50-year sentence, he was strangled in his cell by his cellmate. It appears that Dyer had been attempting to justify his actions, which his cellmate found intolerable.

Richard Munro.

This former detective was incarcerated for tampering with witness statements during a murder investigation. Tragically, shortly after his arrival in prison, he was assaulted by another inmate using a sock filled with pool balls. After the attack, Richard was immediately taken to the hospital and, upon discharge, was relocated to a different cell.

Peterson was sentenced to 38 years in prison for the death of his third wife, Kathleen Savio. After being transferred to a high-security facility, he was assaulted by an inmate using a food tray in the dining area. While he wasn't severely injured, he was subsequently separated from the prison's general population for his safety.

[Nicholas Tartaglione.](#)

Tartaglione was incarcerated following investigations that linked him to a homicide. Months into his prison sentence, he was severely assaulted in a federal facility, leading to a hospitalization that lasted over two weeks. As a result of the assault, Nicholas underwent reconstructive surgery for a fractured eye socket.

Jason was convicted of the murder of teenager Laquan McDonald and sentenced to 7 years in prison. Held in an undisclosed state prison in Illinois, he was beaten in his cell by several inmates four hours after he was placed in a general population unit at the prison.

[Deniz Jaffer.](#)

Along with his partner Jamie Lewis, were imprisoned for taking photographs of two murdered sisters at a crime scene they were assigned to protect. During Jaffer's sentence of two years and nine months, he faced assaults from three separate inmates. Similarly, Lewis was attacked twice during his incarceration.

[Kim Potter.](#)

In April 2021, Kim Potter fatally shot Daunte Wright during a traffic stop. In her defense, the 26-year veteran asserted she had intended to use her Taser, not her firearm. After serving 16 months of her two-year prison sentence, she was released due to concerns about her safety, as she faced threats from other inmates.
