- Page 8, Article VII, Section 5 -- Quorum for Association meetings
- ☐ Page 9. Article VIII, Section 2 -- Duties of Executive Board
- □ Page 10, Article VIII, Section 6 -- Quorum for Executive Board meetings
- □ Page 10, Article VIII, Section 7 -- Express rule stating that all votes must be given in person.
