In this introduction section, please use Garamond font with a size of 13, single spacing, and no additional space before or after paragraphs. Ensure the use of proper academic English. If there are borrowed words or if you need to include acronyms or abbreviations in non-English languages, please italicize them.

The introduction must clearly articulate your research phenomenon and your current research position among other studies. Discuss how your research relates to existing studies, with a particular focus on relevant scholarly articles. It is mandatory to use references from reputable international and national journals.

Clearly explain: (1) why your topic needs to be researched; (2) how previous research has addressed the topic and what gaps remain and and describe the current state of the art; (3) if your research is novel, provide a well-supported rationale grounded in various theories; and (4) how your research will contribute to future scholarship.

The research methods and literature review should not be discussed here, as they will be covered in separate sections below.

# 2 Literature Review (Segoe UI, font size-13 pt, before after 0)

It should be written Garamond font with a size of 13, single spacing, and no additional space before or after paragraphs. The Literature Review contains a systematic description about result of research that has been carried out by previous researchers. This section also contains a theoretical studies consists of a summary of theories are taken from literature that support research, and contains explanation of the concepts and basic principles are needed for problem solving, literature Review and Hypothesis Development, contains previous literatures related to the research and explains the hypothesis development. In this section also, must be explain novelty from previous research.

In this section, the author must outline the conceptual framework (for both qualitative and quantitative research) and the research hypotheses (for quantitative research). In quantitative research, the relationships between variables may be presented using subheadings. Subheadings are permitted but should be written without numbering; simply write them in bold.

Citations must be managed using Mendeley or Zotero software in APA Style 7th edition. Citations should reference recent articles (published within the last 10 years); include at least 10 articles from reputable international journals; a minimum of 5 reputable supporting books; and reputable national articles. # 3 Research Methods (Segoe UI, font size-13 pt, before after 0)

In quantitative research, the required classical assumption tests are the normality test and multicollinearity test.

If your research is qualitative, we accept qualitative research with literature review and case study methods. Qualitative case study research uses a case study approach to explore economic and management practices within the selected organization. This design allows for an in-depth understanding of complex phenomena in a real-life context. Data is collected using semi-structured interviews, allowing for flexibility and depth in responses. Additionally, document analysis of relevant organizational reports, policy documents, and meeting minutes is conducted to triangulate the findings. The data analysis method must be clearly outlined.

On the other hand, literature review research uses a literature review method to analyze and synthesize findings from various sources relevant to the studied topic. Literature reviews provide a deep understanding of the current state of research, identify research gaps, and determine directions for future research. Literature searches are conducted in major academic databases such as Google Scholar, PubMed, Scopus, and JSTOR to find journal articles, books, dissertations, and conference reports relevant to the research topic. 


Figure 1. Partial Least Square
