## Soap Critters End User License Agreement

**By purchasing or receiving a license, you are agreeing to abide by the terms and conditions of using this product.**

If you do not agree with these terms, do not purchase, download, or utilize this product.

"My", "I", refer to ironicsoap. "Product", "Avatar", and "Content" refer to anything I have listed up on my store platforms, for sale or download.

---

When purchasing my products, you are purchasing a license for a **single person** to use the product.

This license is non-transferable except through an agreement with me.

---

The product's files are provided "As Is", I am not responsible for ensuring your ability to use the product files.

I *will* try my best to provide accurate documentation, tech support, and bug fixing updates; as well as ensuring that the product continues to work with future VRChat updates, *but this is at my own discretion*.

I disclaim all liabilities & warranties, express or implied, for the product.

### 1. Redistribution Terms

- a. You will not re-distribute any part of the licensed product files to those who do not own their own respective license(s) for them.
  - i. With the exception of uploading a Public avatar onto *your own* VRChat account.

### 2. Content Terms

- a. You will **not** use, feature, or create assets for the product for these purposes:
  - i. **Sexual(18+) and / or Fetish content**
  - ii. Hate Speech
  - iii. Generative AI (Dataset training or AI filters)

iv. NFT & Crypto

3. **Commercial Use Terms**

- a. Avatar editing / texturing commissions are allowed, provided all parties own their own licenses to the product(s) being used, and they follow the **Content Terms**.
- b. Selling / Creating assets for my products is allowed, provided that:
  - i. The product follows the **Content Terms**
  - ii. You do not include any of the original product's files
  - iii. You state that the avatar is not included in your product
  - iv. You do not use my logos or branding to advertise with
    1. Do not include "ironicsoap" in your asset's title  
Ex: "Soap Critter Sunglasses" is ok!  
but "ironicsoap's Soap Critter Sunglasses" isn't
- c. You may use my products commercially as a streaming avatar, **as an individual**.
  - i. [Please contact me first](#) if you work for a *brand / group / company* wanting to use one of my products, or if you want to use *renders* of the model commercially (like stickers and shirts)
- d. You must [contact me first](#) to make a separate agreement if you wish to use the product commercially in a way not outlined within this EULA.

**What happens if you break these terms?**

- You will be banned from all community spaces I moderate (Discord and VRC Group)
- Your license to my content may be revoked if the violation is severe enough

If I believe a violation to be a mistake, I will try my best to reach out in good faith before taking action. This is at my own discretion, it is ultimately your responsibility as the one agreeing to these terms to follow them.
