"Hello. My name is ____ and I'm calling on behalf of Kevin Johnson #1007485, who was recently transferred to your Nottoway facility in medium security. Kevin has been subject to constant abuse and mistreatment in many different facilities. Recently, he was issued several write ups, most of which he beat and the last one was lowered. One of the officers even testified that the write up was false. We demand the following:

1. That he be released from segregation and be given access to general population property and privileges
2. That he be put in an actual quarantine unit if quarantine is legitimate
3. That he not be subjected to a retaliatory transfer AND that his classification level NOT be raised as retaliation for beating the write ups/charges.

We want you to know that Kevin has our full support, and that the world is watching in order to hold you accountable. Goodbye."
