

AGREEMENT TO CONTRIBUTE TO OPENLY LICENSED PROJECT

at the University of Hawai‘i

I. Project Description

Project name (“*Project*”) is for **faculty name**’s **course number and name** course at **campus** within the University of Hawai‘i (UH) System. This *Project* may include materials such as text, media, artwork, and related products. This is an agreement (“*Agreement*”) between student and instructor, related to the *Project*, which will be released to the public under a Creative Commons (CC) license.

II. Student Agreement

I hereby give permission, in perpetuity, to the University of Hawai‘i (comprising all campuses in the UH System) and **faculty name** to include any materials (text, media, artwork, related products, or any other works) that I have created or contributed to in the *Project* (collectively my “*Materials*”). I confirm that these *Materials* are my original creation, that I own their copyright, and that I am legally entitled to grant the license set forth herein this Agreement. I understand that:

- My contributed *Materials* must be licensed under a CC license to be included in the Project. I have read “[About the Licenses](#)” and understand that a CC license may allow others to share, use and adapt my work.
- The UH System may make the *Project* and *Materials* publicly accessible and available for various uses including but not limited to: reproduction, redistribution, display, adaptation, revision and creative reuse. I acknowledge that the UH System is not responsible for how the *Project* or *Materials* are used by others.
- I have the right to use a pseudonym, change the license on my contributions at any stage prior to publication of the *Project*, or to request in writing that my name and/or *Materials* be removed from the original text. I acknowledge that CC licenses are irrevocable and once the *Project* is published, anyone who had access to a copy of the *Project* could continue to use and redistribute my *Materials* under the CC license.

To the extent that the *Materials* were created as part of my participation in **faculty name**’s **course number** course and are part of my educational record under the Family Educational Rights and Privacy Act, I consent to the release of these *Materials* to the public with the publication of the *Project*.
