- a. Treasurer's update
- i. Patrick has been able to get ahold of the quickbooks, and review the last 5 years
 - ii. Wanted to look at the finance overview to plan our budget for this year considering some of the new events on the table
 1. Plan to have a list for March meeting to approve
 2. \$150 for easter egg hunt, \$400 to get a dumpster (normally brings in around \$600), Ice cream social (few hundred dollars), Business registration (website, (\$140), Insurance \$2800 (500 for board, 2300 for building), Utilities cost 2700, 200 for movie in the park, wildfire \$200
 3. Movie will be \$500 if it's at the park, free if it's on the KCA property
- b. Canyonfest committee
- i. At this moment we are putting on the breaks for Canyonfest and focus
 - ii. Concern for additional issues per the creek
 - iii. Not sure about the future of the building - focus on rebuilding community instead of focusing on it going into community
 1. More potlucks, keep connecting everybody
 2. Community needs to reunite
 - iv. Sponsorship - platinum, gold, silver, bronze
- c. Property Committee
- i. Don't have enough money to replace the deck
 - ii. Won't have enough money to pay for the building if the waterboard goes away next year
 1. Building is jointly owned between KCA and the Water District
 - a. The waterboard is going to release ownership of our treatment plant to the evergreen water board - Kittredge cannot afford to maintain it so
 - b. The KCA is in a similar position where we can't really afford the building to keep it year over year

- c. Patrick and Mike went to the Water district to ask if they would be willing to request 50k in funding for the building, what we want to do to improve the building, and what we do and have done in the past.
