**DoJ Directive #069**

**SUBJECT: Dixie Police Reform Initiatives**

**(I) Short Title**

- (a) This Directive shall be titled "DoJ Directive #69 : Dixie Police Reform Initiatives".

**(II) Creation of the D.C.P.M. and the L.E.M.P.**

- (a) The Dixie Commission on Police Misconduct (D.C.P.M.) is hereby established and authorized to investigate and report on the following:
- (i) Instances regarding the use of force on a civilian;
  - (ii) Instances regarding allegations of racial profiling;
  - (iii) Instances regarding whether or not police procedure was followed.
- (b) The D.C.P.M shall be staffed by the Attorney General, The Director of the Department of Law Enforcement, Solicitor General, and two independent monitors chosen from a pool of qualified and interested applicants.
- (c) The Commission is authorized to view the following records without delay:

- (i) Any and all body cam footage that may or may not relate to the case at hand;
  - (ii) Any and all arrest and witness reports;
- (d) The Law Enforcement Misconduct Portal (L.E.M.P.) is hereby established and will contain the following records:
  - (i) Any and all complaints against a law enforcement officer employed in the State of Dixie;
  - (ii) Any and all previous complaints of misconduct before the establishment of the aforementioned system;
  - (iii) Any and all complaints of misconduct of a law enforcement officer who was previously employed by another department and/or agency outside of Dixie.
- (e) The D.C.P.M. shall be authorized to hire a total of 15 detectives and 4 forensic scientists to assist with the commissions investigative powers.
- (f) I hereby allocate \$150,000,000 from the Department of Justice discretionary spending to fund both the Commission and the Portal through Fiscal Year 2021.

### **(III) Monitoring of Local Law Enforcement**

- (a) To prevent the destruction of vital evidence and records, whenever an instance of police misconduct is reported, the D.C.P.M. shall takeover as the lead investigatory agency. The detectives authorized in the aforementioned section shall be authorized to question and interrogate potential witnesses and suspects.
  - (i) Any and all recordings of the aforementioned questionings shall be made available to the public upon the conclusion of said investigation.
- (b) Knowingly destroying records sought in an investigation by the D.C.P.M. shall be prosecuted under Dixie Statute 119.02.a or 119.02.b.

### **(V) Enactment**

- (c) This Directive shall take effect immediately upon posting.
