Important Guidelines

2. Only those Candidates who have registered , verified documents, and confirmed the application form for admission with CET CELL - SC (Scrutiny Centers) will be eligible.
3. Eligible and interested candidates may apply by submitting their application via Google Form <https://forms.gle/nXNUpQpxC1ZXt53E8> and paying a one-time, non-refundable application processing fee of Rs. 1000/-. The last date for submission is August 28, 2025 (date of allotment of CAP round 4) as per the notification by State CET Cell.
4. **This is a common one-time application form for Against CAP (SPOT) i.e. Vacant Seats after CAP Rounds (if any).**
5. The merit list, seat allotment details, and instructions for reporting to the institute to confirm admission will be available under the Admission tab on the institute's website.
6. Candidates should fill out the Google Form carefully with the correct information. Once submitted, the form cannot be changed. If anyone provides wrong information or fake documents, their admission can be canceled at any time.
7. All Institute level admissions will be done as per merit and referring to the guidelines specified in admission notification published by CET Cell.
