 - v. We increased field trip funding this year and hope to increase even more in 2017-18 when we are no longer responsible for Franklin Covey (Leader in Me) dues
 - vi. Added funding for Handwriting without Tears program
 - vii. Added funding for Theater Arts program (Mary Jo to spearhead this)
 - viii. Increased mini-grant budget
 - ix. Increased teacher discretionary fund from \$200 to \$275
 - c. Sarah moved to approve 2016-17 budget, Mary Jo seconded the motion - approved
