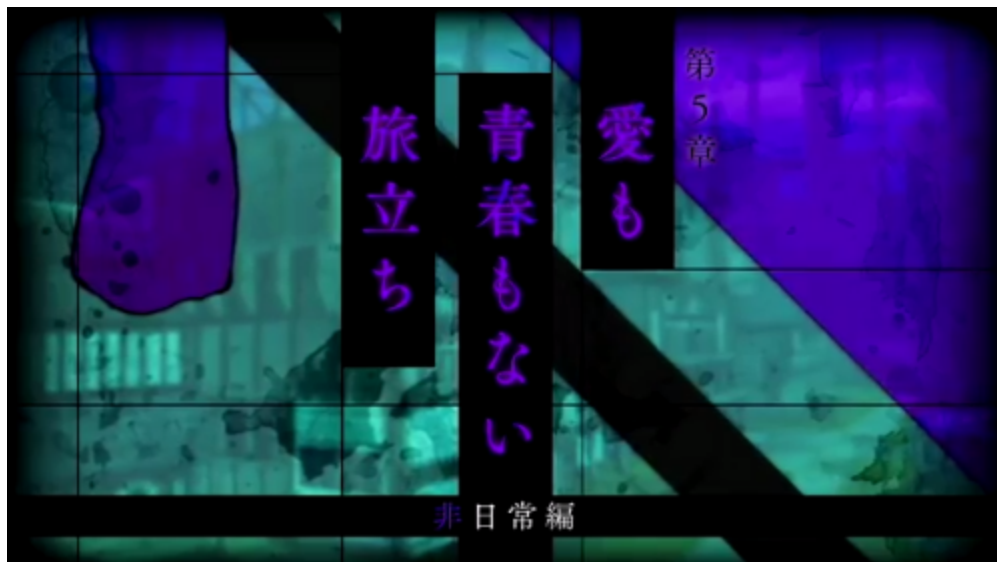

...Huh?

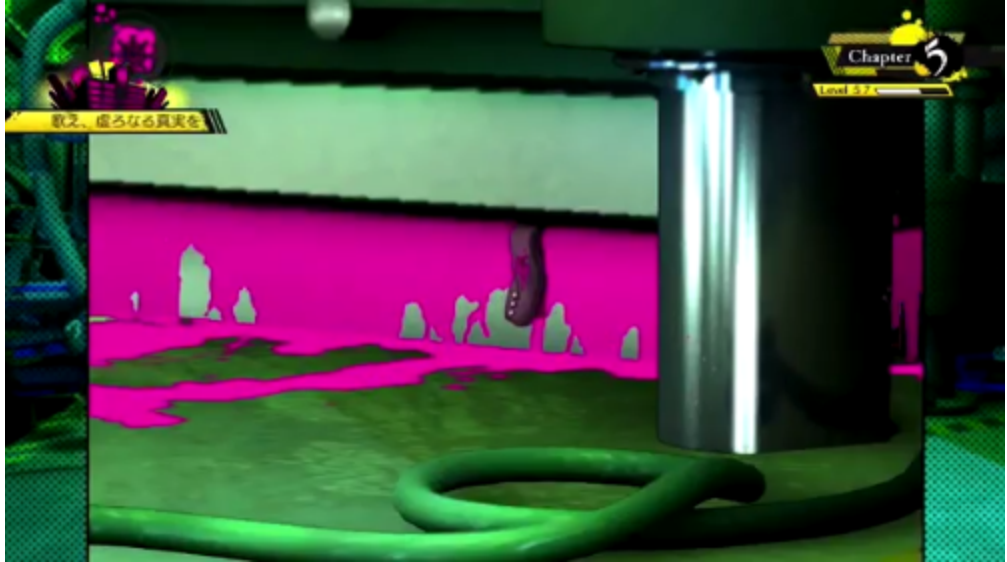


**Momota-kun or Ouma-kun is dead?**

With that said, here is the Monokuma file!



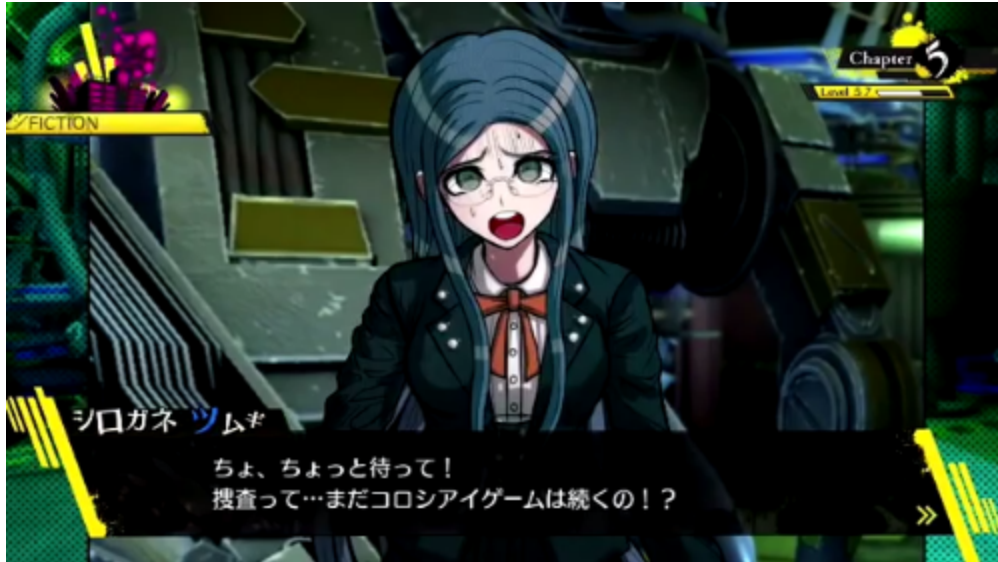
Don't tell me you're tired already! The interesting stuff has only started!

Everyone still knows. But, why Harukawa-san...



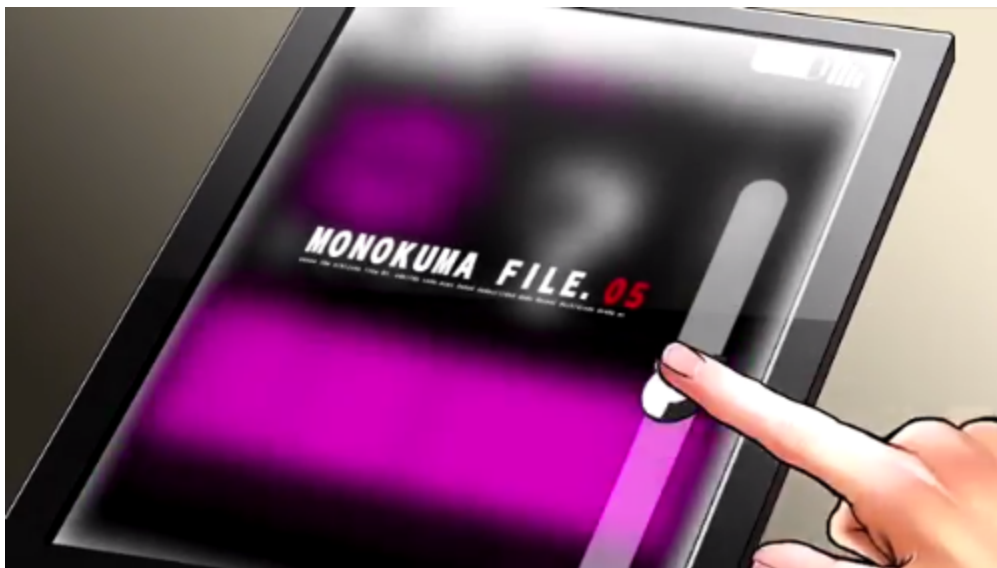
How can she take Momota-kun's death so easily?

Wait, Harukawa-san. We can't decide that just yet.

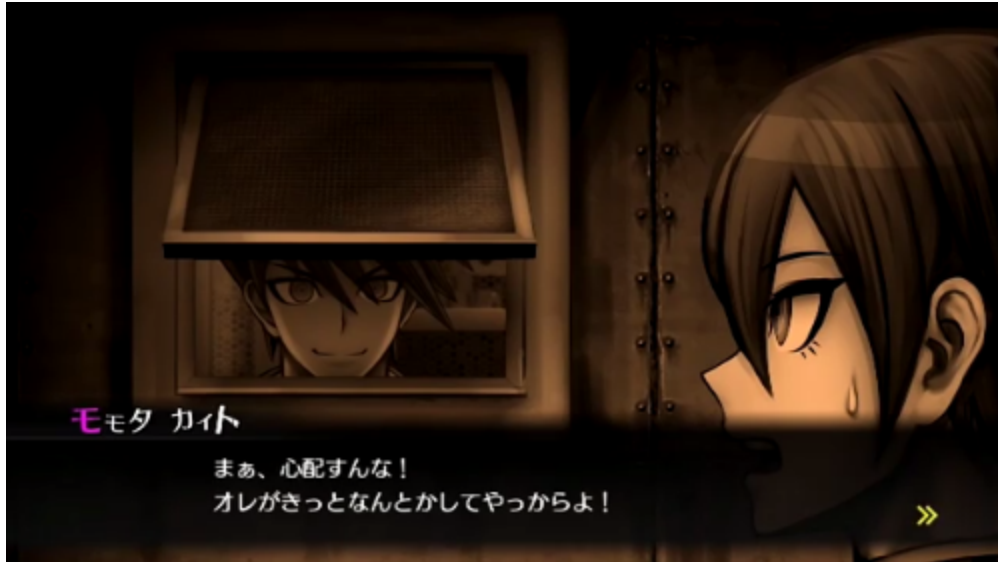


True, everything so far has shown that Ouma-kun is still alive...



However... Momota-kun said.

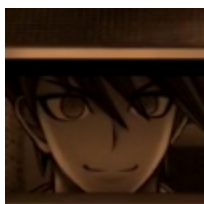




Don't worry! I'll do something!

But now that Momota-kun was killed, now that tactic is gone...

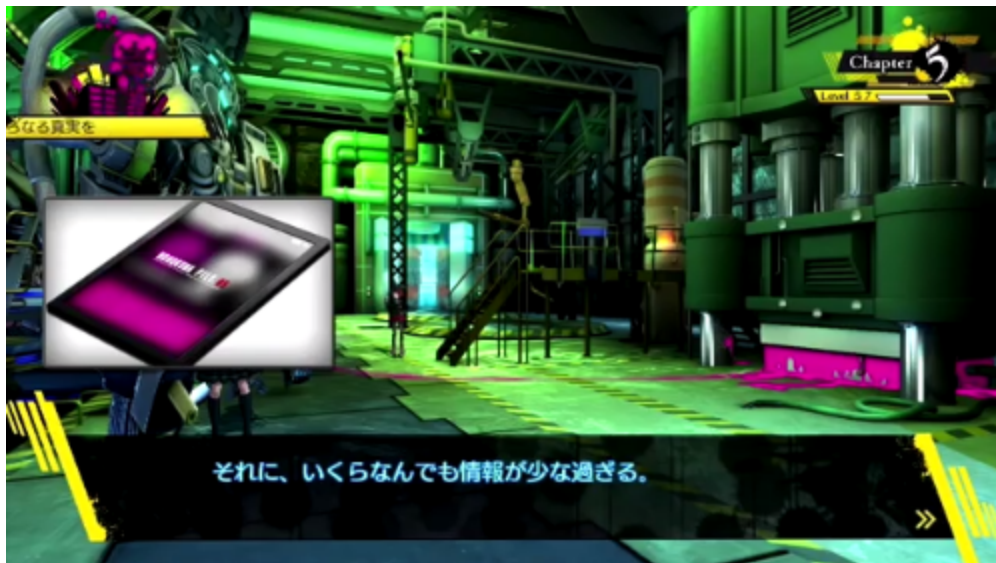

...I will begin investigating!



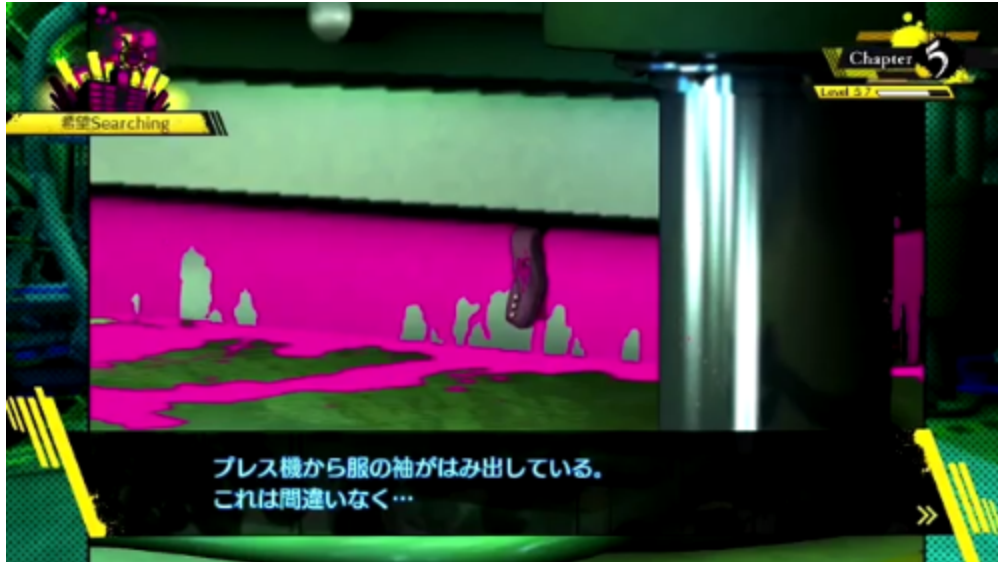
## INVESTIGATION: BEGIN

This is the sleeve of Momota-kun's jacket.

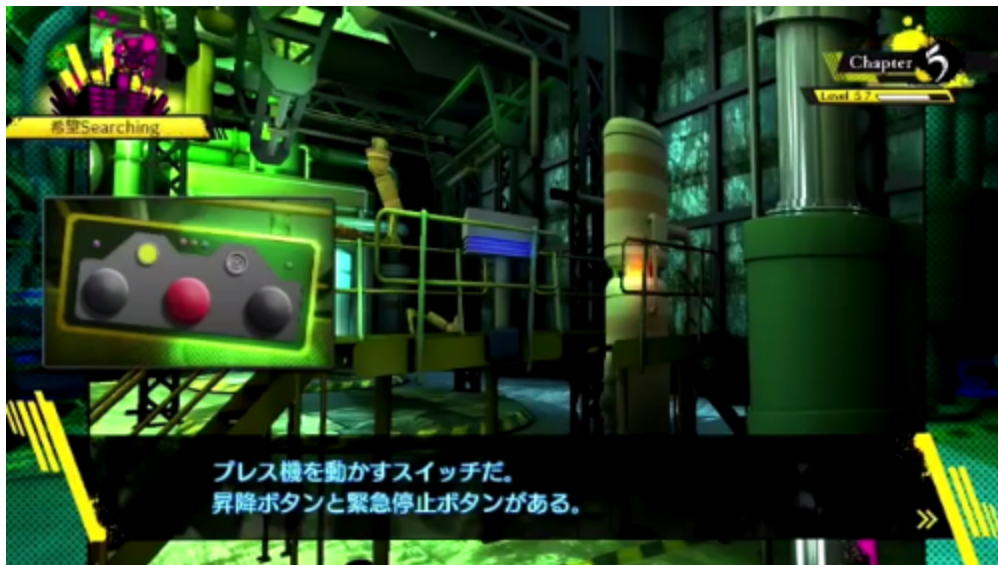
Well then, the victim has to be...

.....



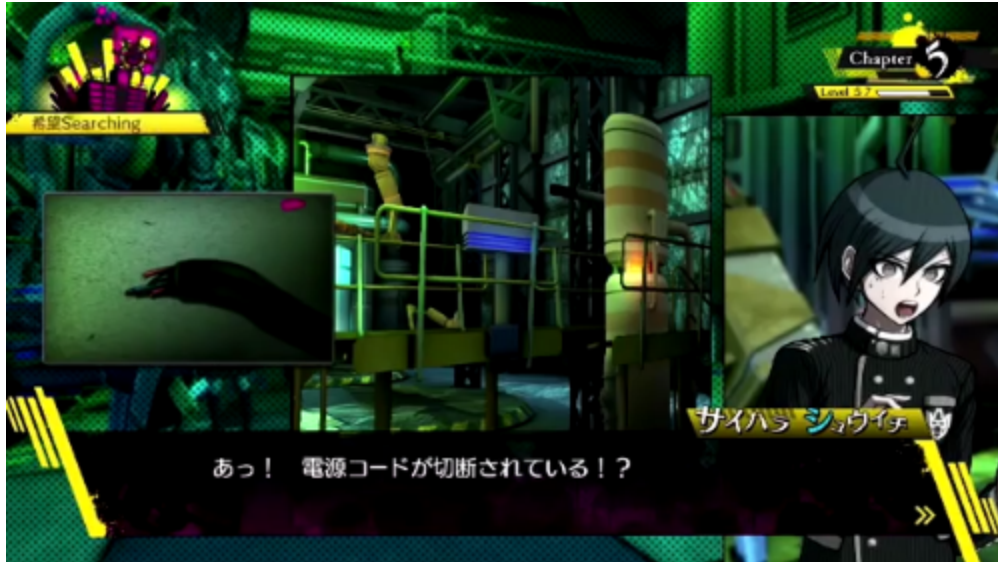
...Huh? It won't move?

I think I should research more about the switch. There might be some clues remaining...

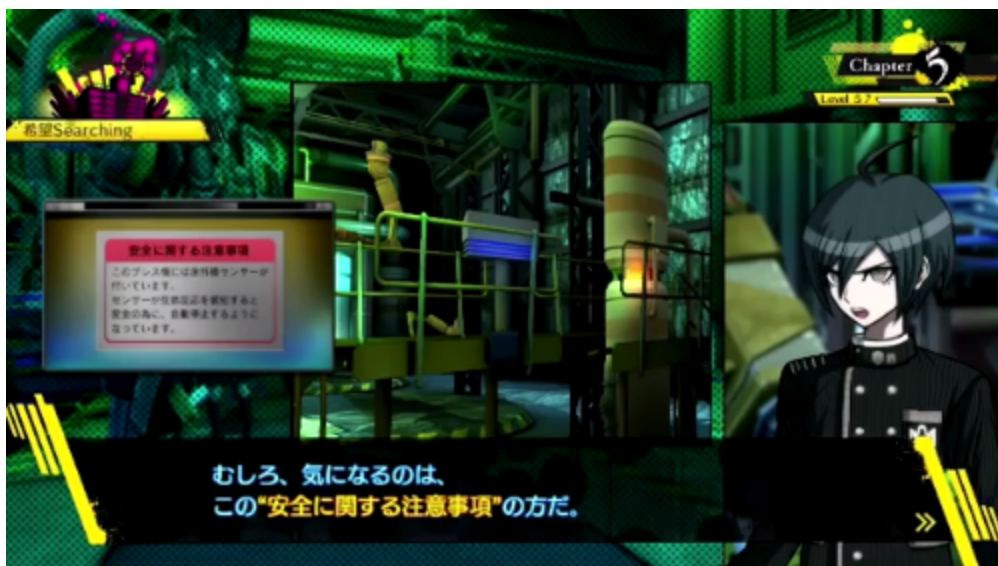


Huh... Other than an ascend and descend button, there is a force stop button.

Even though I tested it out on Kiibo-kun, it didn't stop...

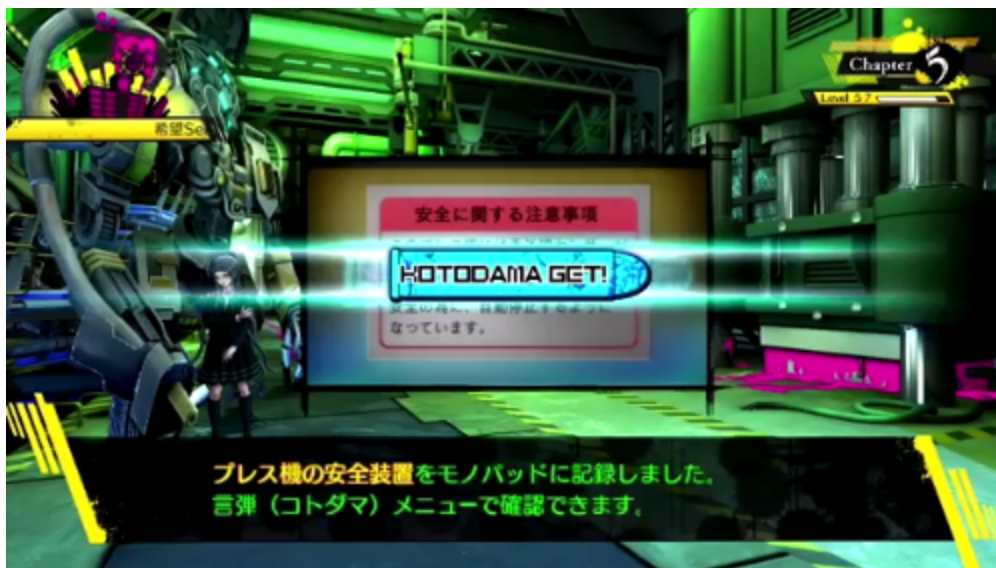




Normally, if a person is inside the press, the infrared sensors would detect them and stop automatically.

I'll turn your hair into an afro with my magic!

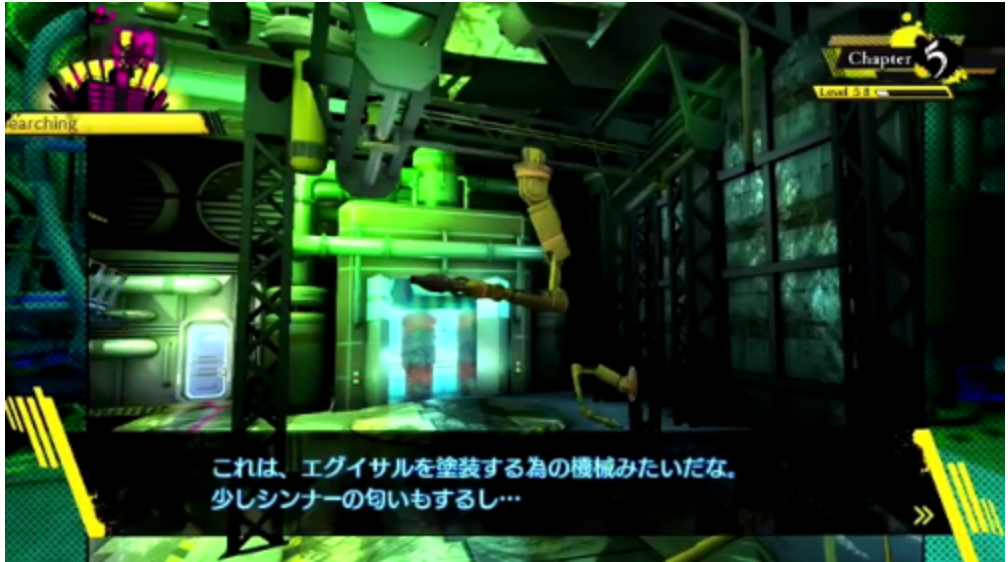


...She seems very ticked off. She does suspect me, doesn't she?

Did he have it from the start? Did him as the mastermind have it prepared?

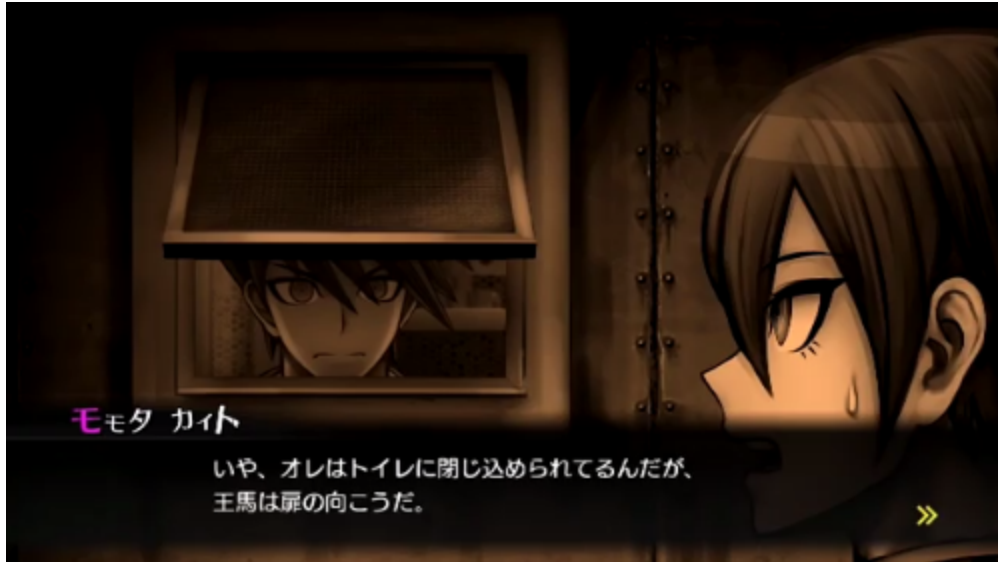




This... is the bathroom.

Well then, Momota-kun might have left some clues here---



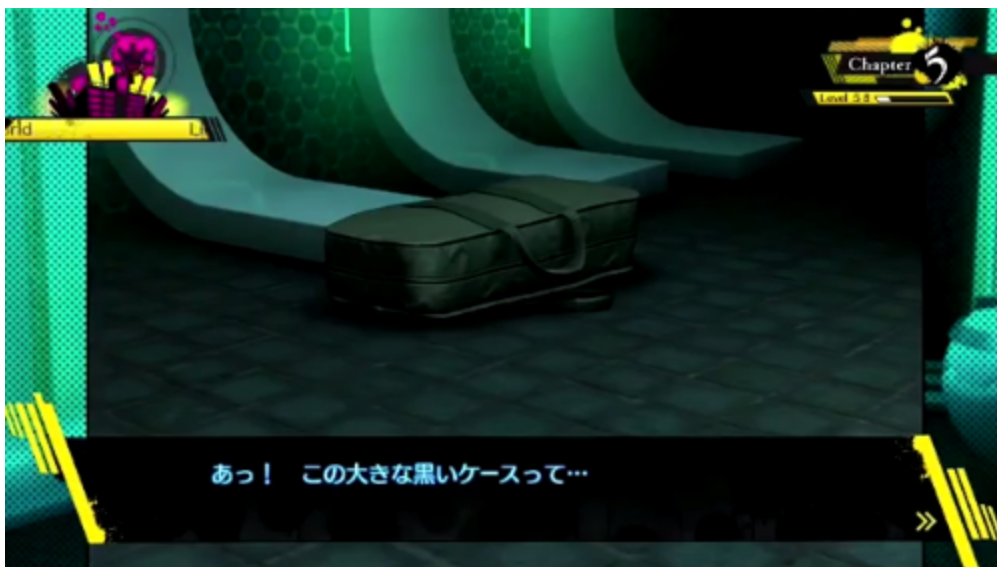
Hmmm... it would be kind of weird if he had actually left some for us. I mean, we don't know if he's actually dead yet...



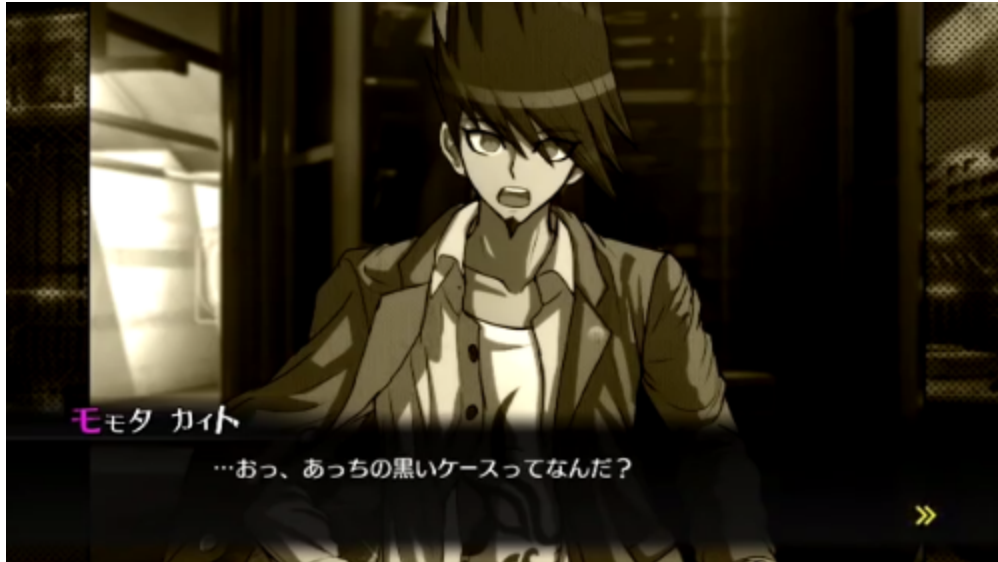
For now... let's look inside.



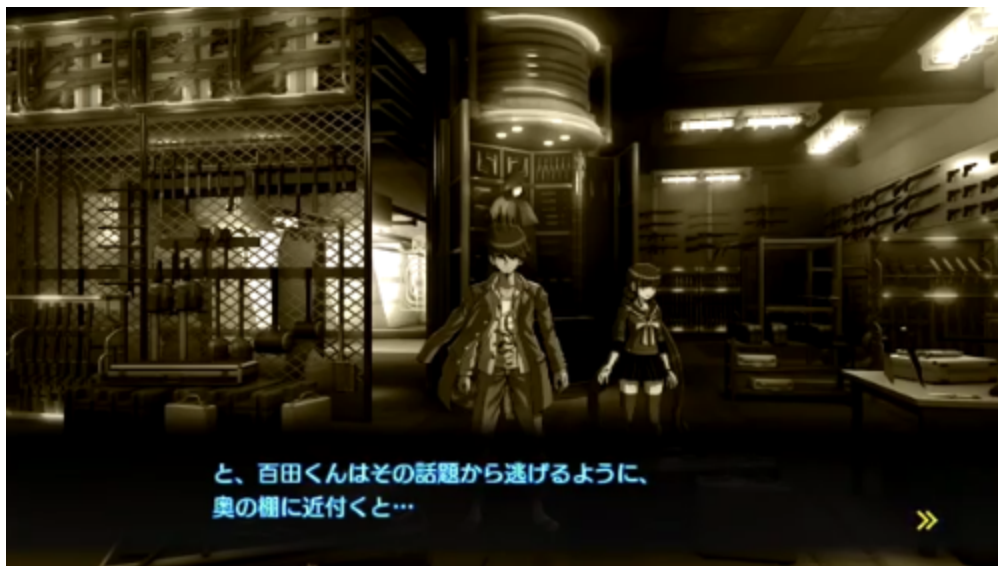

That case... was?



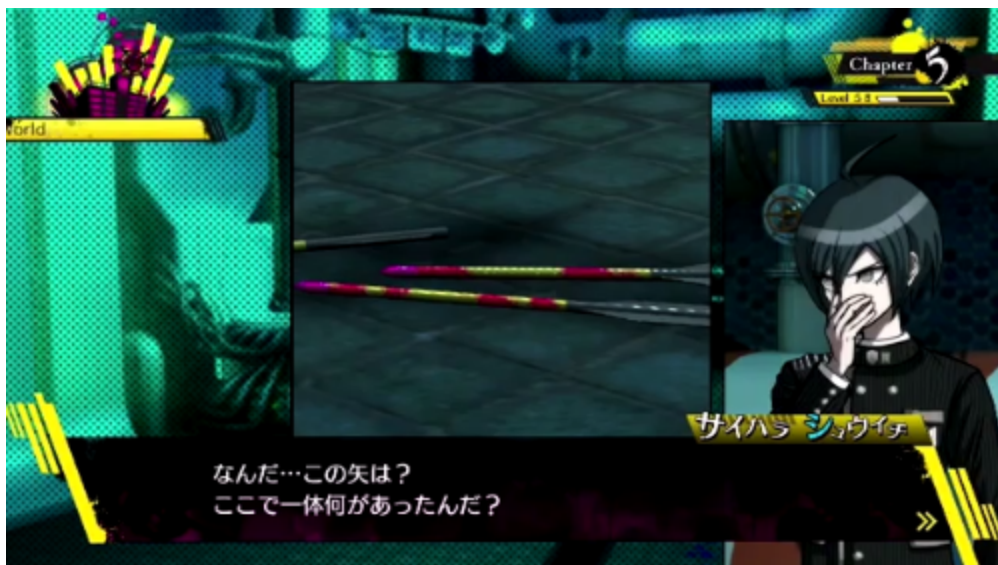

Something is dropped on the floor of the bathroom...

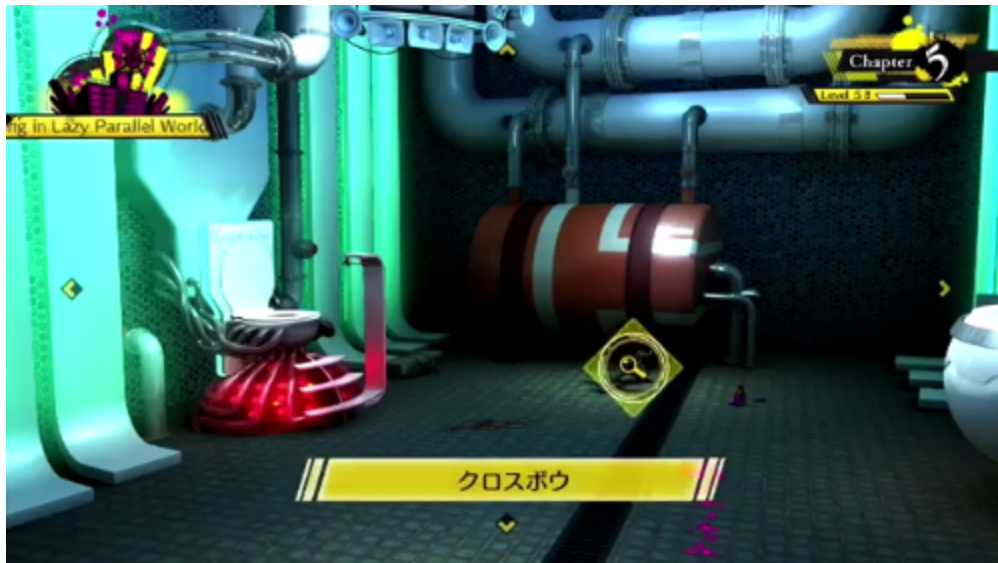
There are three arrows. Moreover... they all have blood on the tips...

“**Poison**”, could this flask have been...



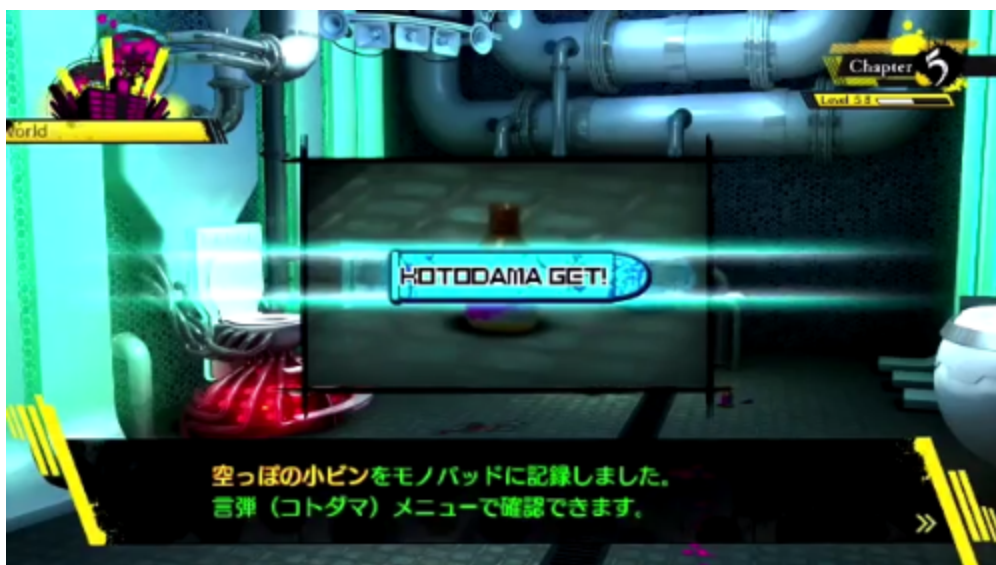
...from my **Research Room**?

Are these... bloodstains?

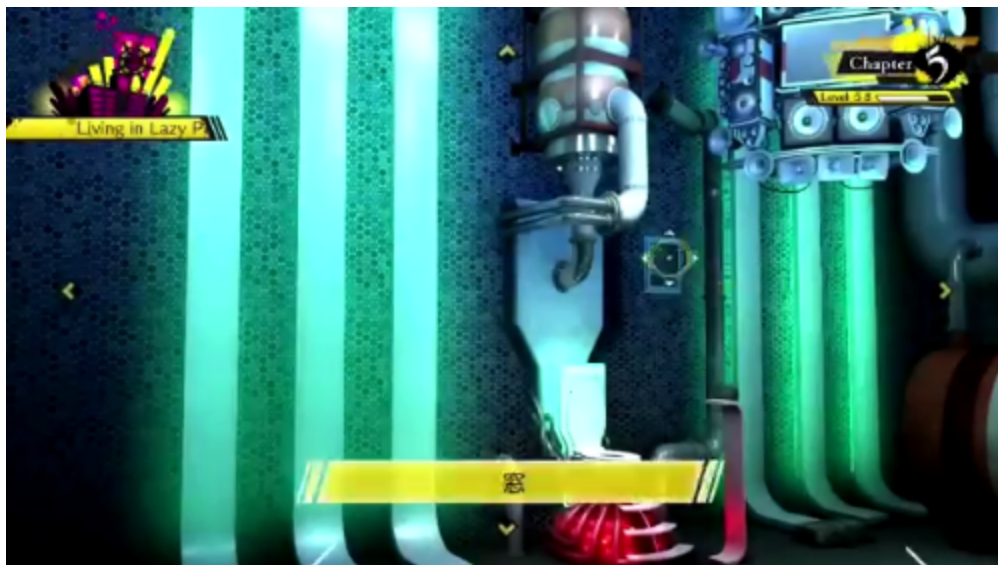
They are right in the middle of the bathroom. And they seem to be heading towards the door...

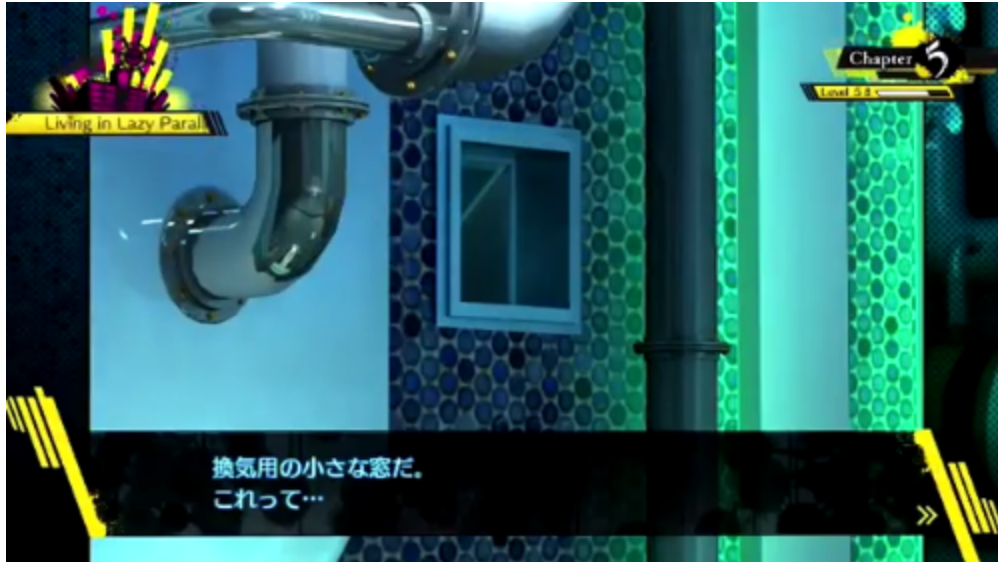


What do these bloodstains mean?

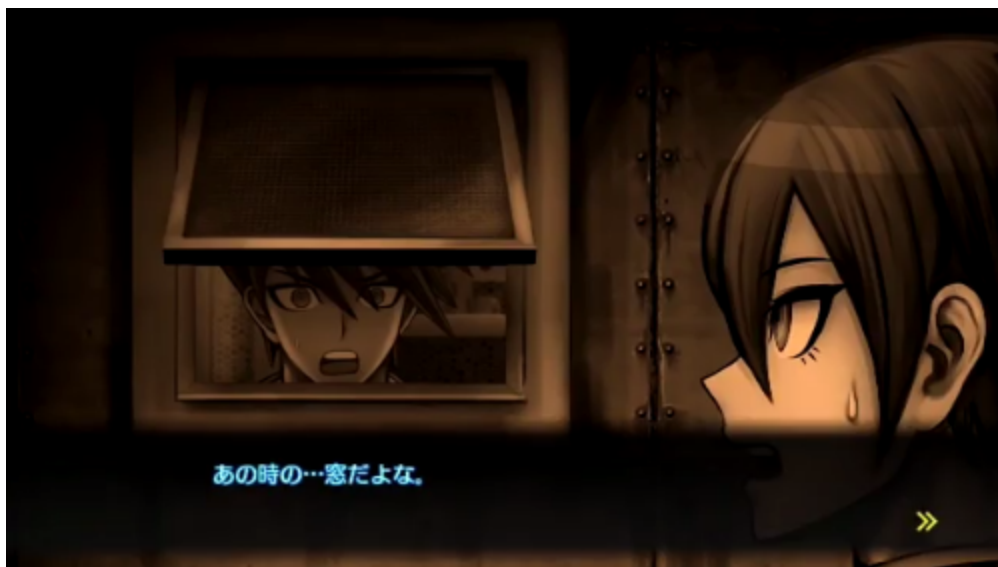


**BLOODSTAIN WAS ADDED TO EVIDENCE.**

Even if it's impossible for people, **things** can still go through here

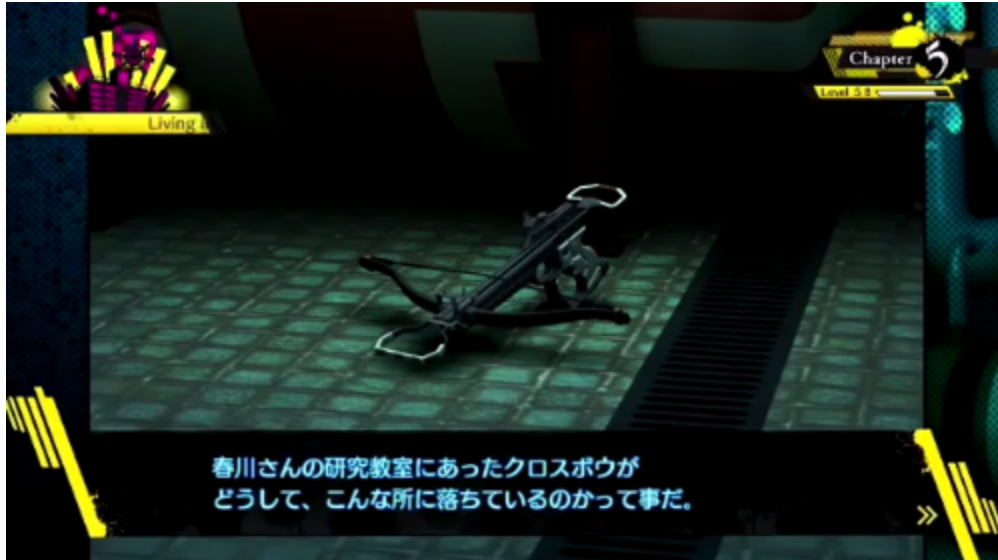


**BATHROOM WINDOW WAS ADDED TO EVIDENCE.**

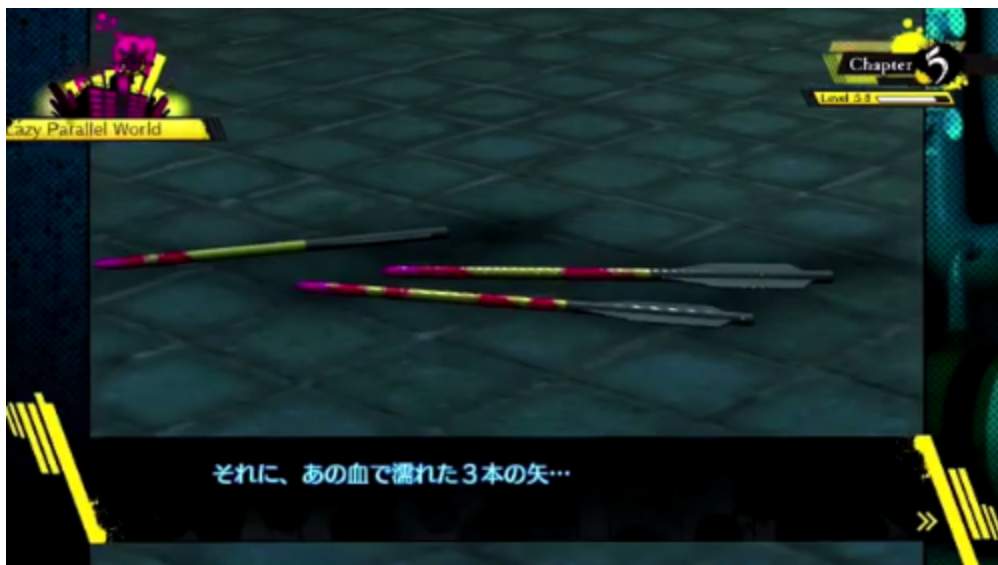


Looks like we searched all throughout the bathroom.

And a small poison bottle... what was it used for?

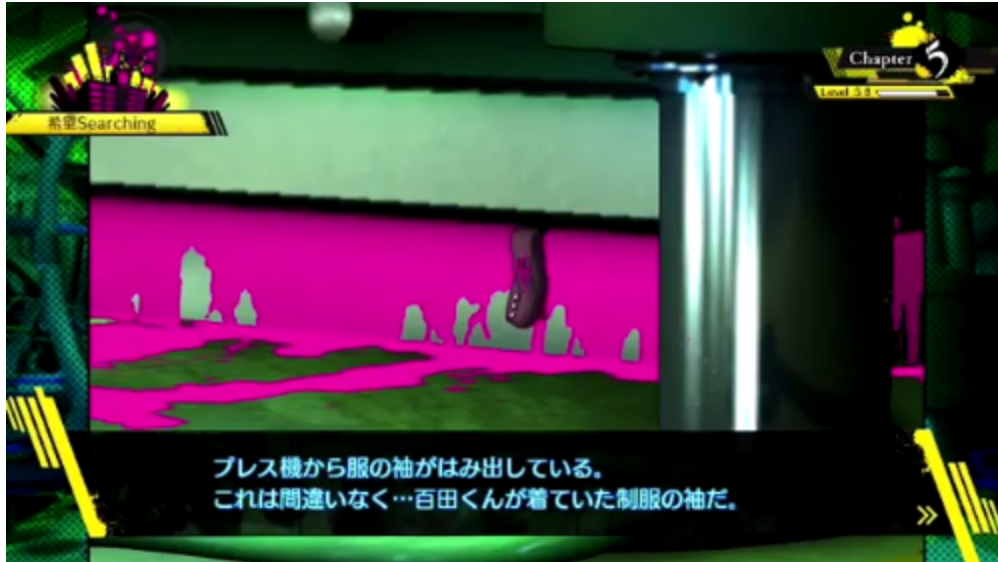


I still don't know anything. It's like nothing is connecting in this case.

Hmm... well, it looks like the one that is hanging out of the press is the left arm.



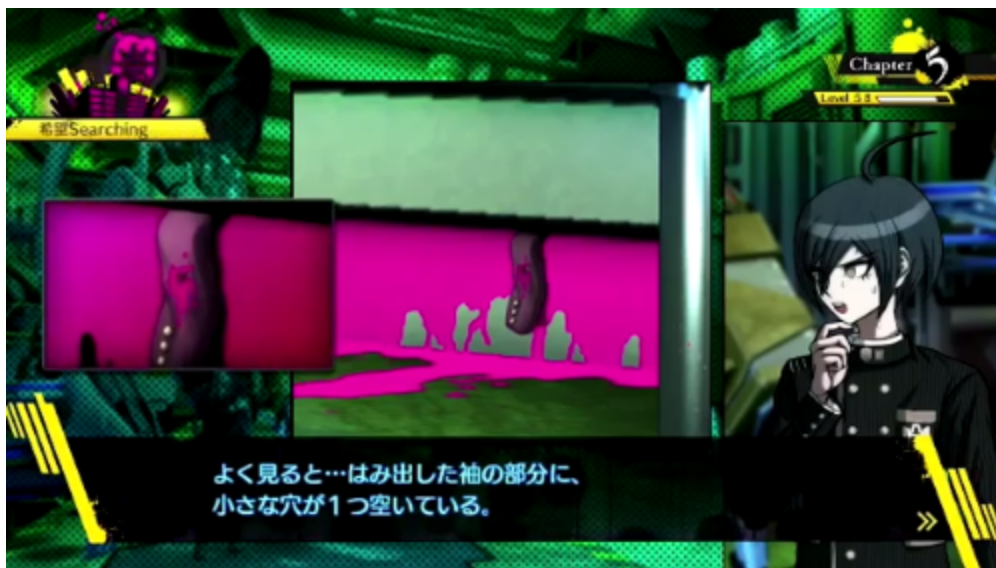
The only thing that's hanging out is the sleeve itself, it looks like the victim's actual arm isn't here at all.



Was the victim completely crushed by the press? I mean, why would the sleeve hang out but nothing else...



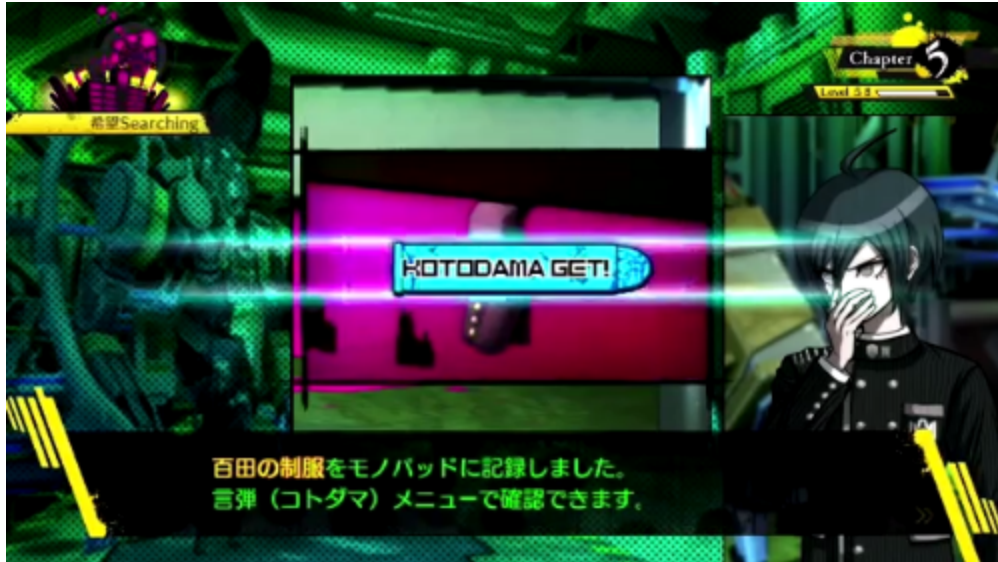
...Huh? What is this?

Actually, when I saw the Exisal, a **certain person** was walking into the hangar as well.



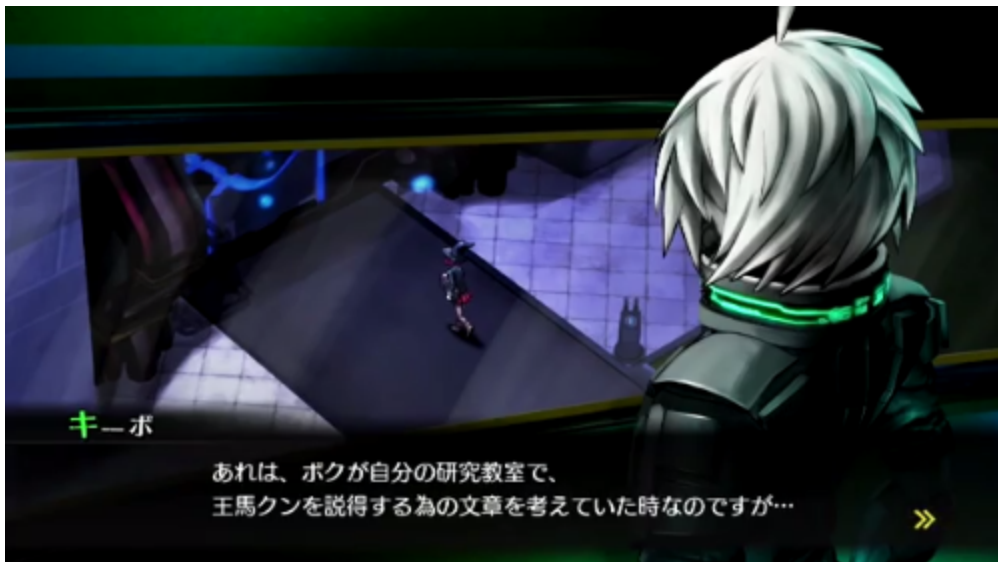
Eh? A **certain person**...

I saw her going inside the hangar. And, in her hands...

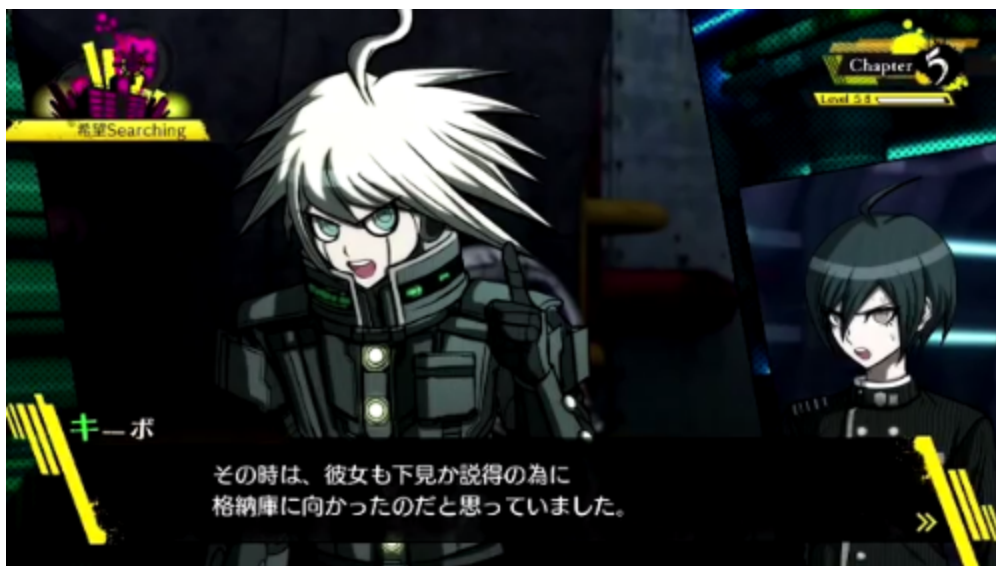


She was carrying a black case.

There is only one window...



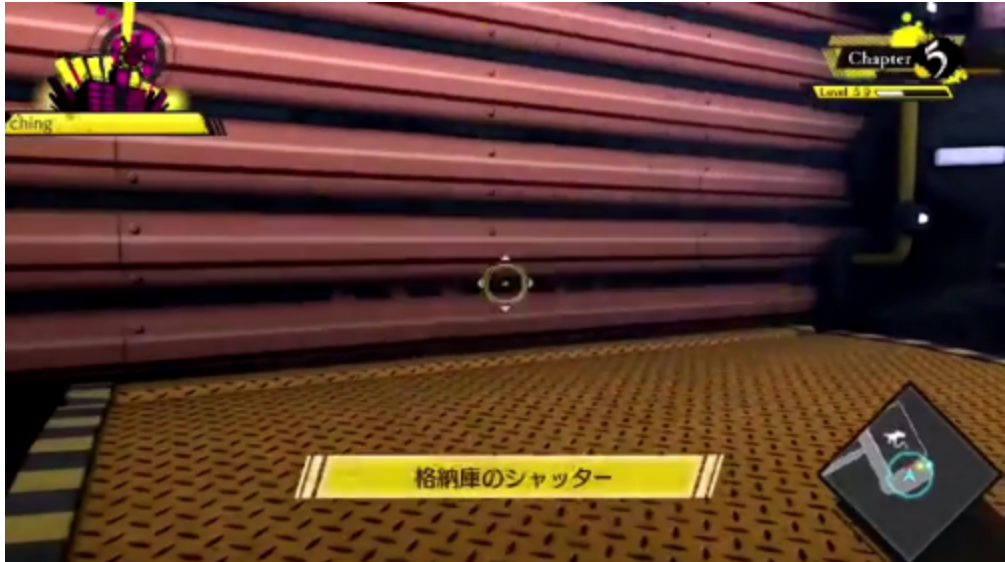
The only way to enter or exit the hangar would be through here or the shutter.



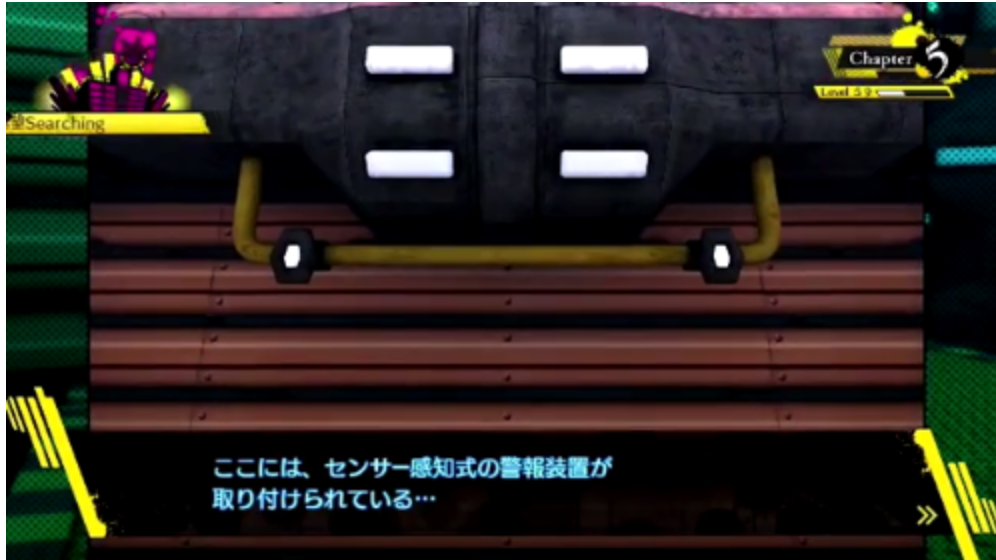
They don't show any signs of moving...

There is a security system with a sensor here...

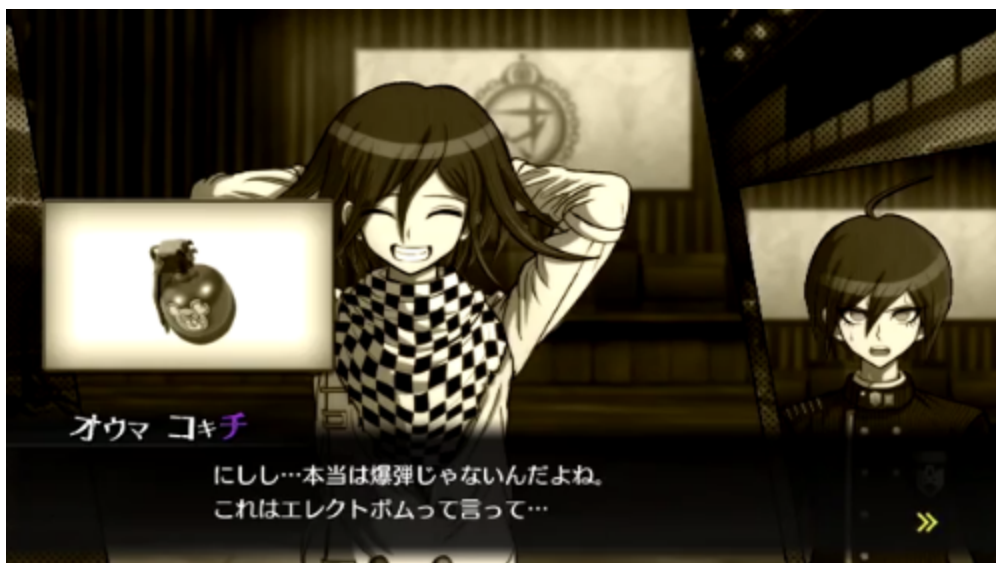
Normally you would need the remote control key to disable it, in order to get close to the shutter.

It doesn't release shrapnel, so it can be used discreetly. They're extremely useful, but I only have three, so they're invaluable...



I'm going to make sure to use them carefully. So make do with the Electro Hammers.

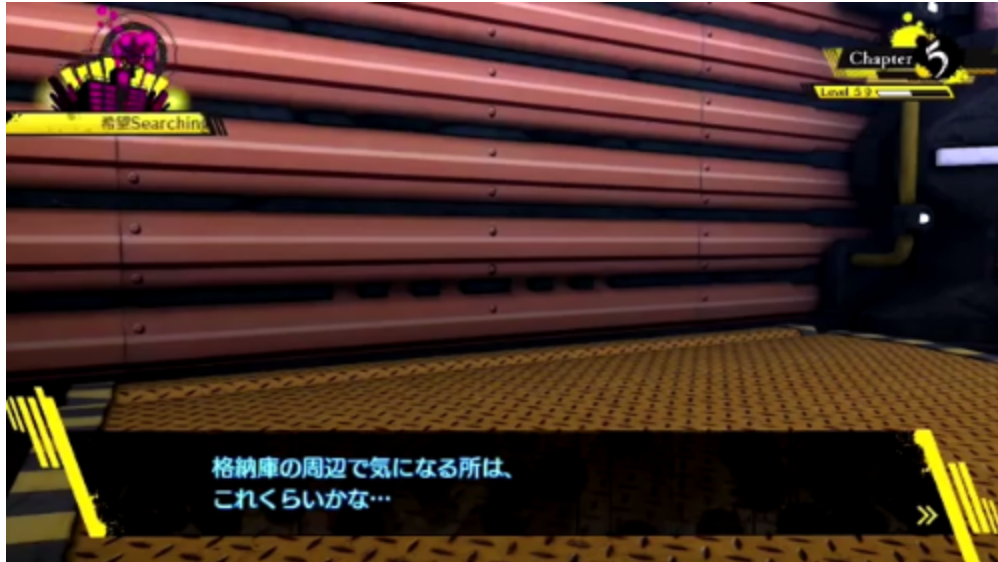


So there were only three Electro Bombs after all...

**ELECTRO HAMMER WAS ADDED TO EVIDENCE.**

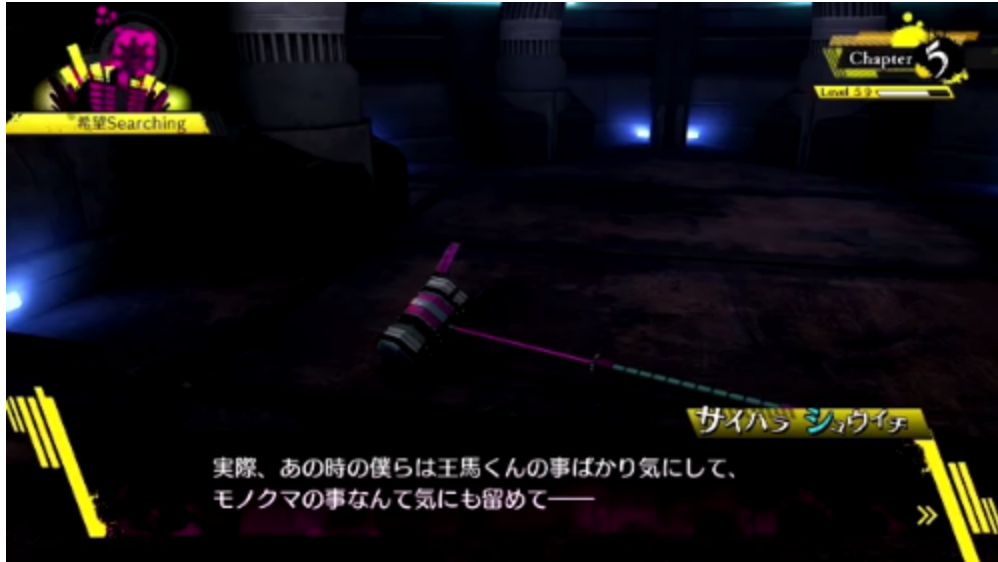
And still, what was is that I saw when I was here yesterday?

That was after Ouma-kun declared himself as the mastermind, shouldn't they be protecting Ouma-kun instead...?

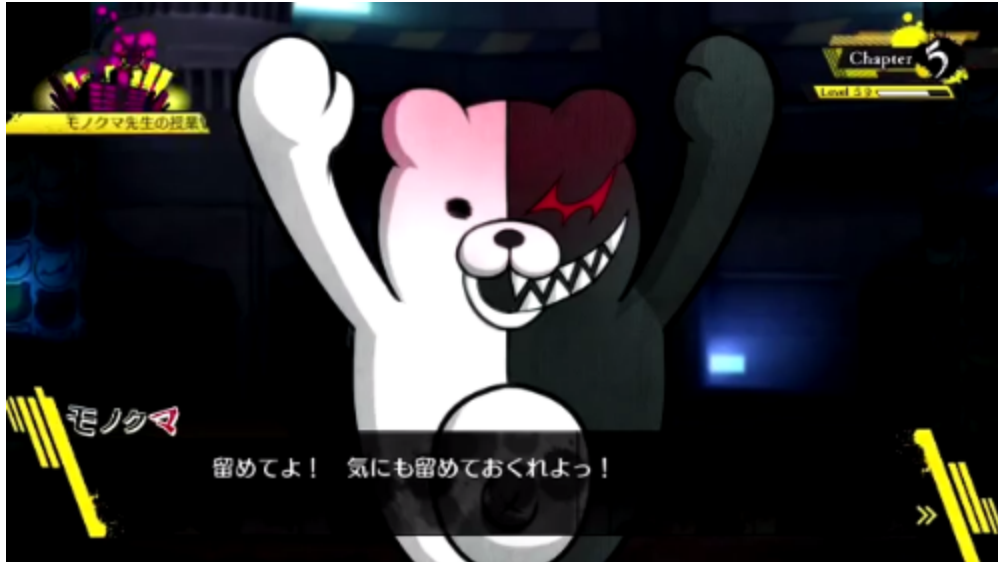
Why were the Exisals protecting Monokuma? And even four of them...

Ah, the Exisals were moving automatically. They were ordered to only focus on me.



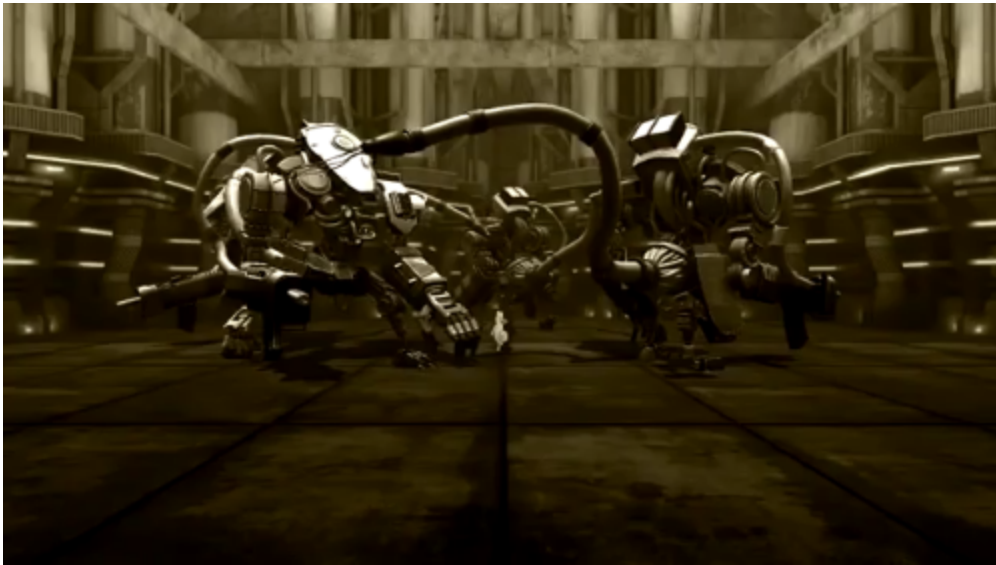
Just like when they were being controlled by the Monokumarz, it's not like they can move on their own.



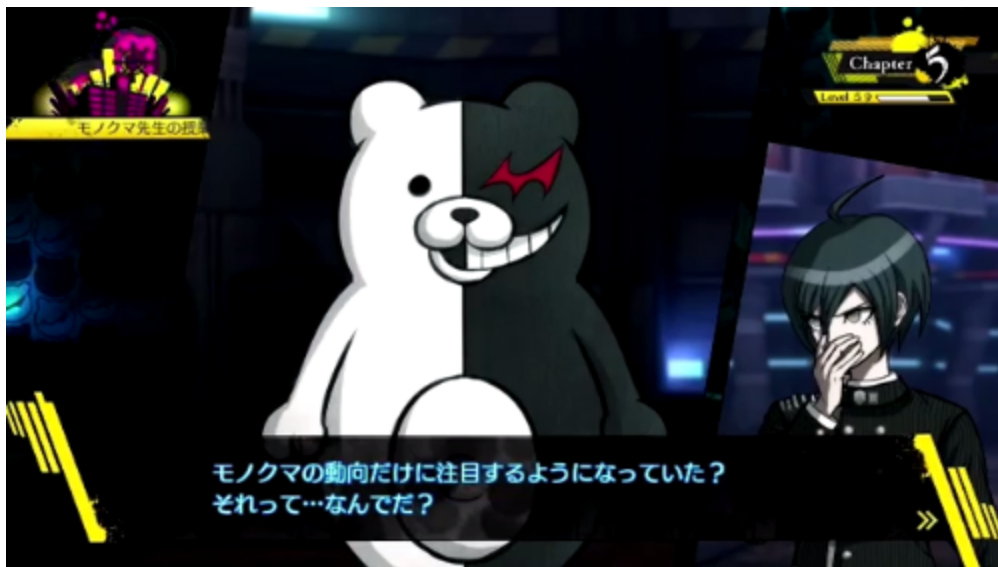
Automatically moving... you mean with that remote control Ouma-kun had, right?
