S.E.X-013 "i have no tits"

Item S.E.X-013

Risk Rating: Harmless

Protection/Observation protocol:

S.E.X-013 is to be stored in a standard anomalous clothing container on site B12 and can only be taken out for testing. Testing may only be conducted after authorization of a formal research proposal by site administration. The organization currently has twelve instances of S.E.X-013 under its protection.

Any new instances of S.E.X-013 should be acquired at level 2 discretion and all civilians involved should undergo "reset" treatment and memory wipes. Exceptions to the "reset" treatment and memory wipes may be made with site administration approval and only if proper cover story has been already set in place.



Description:

S.E.X-013 is series of women's medium black v-neck t-shirt with the words "i have no tits" written in uncapitalized white letters on the chest. When worn by a female subject with a cup size of b or smaller, the item's unusual abilities manifest. The subject's breasts begin to grow in size at a steady rate of one cup size per 30 seconds. This will continue until the subject's breasts reach the maximum sustainable size proportionate to the the subject's body mass. It

seems S.E.X-013 will not expand a subject's breast size to anything that would cause the wearer to be unable to move or cause uncontrollable balance issues.

Discomfort and balance issues may still occur, but not to such an extreme that the subject will be unable to adapt to them in a moderate amount of time. More extreme growth, increases in nipple sensitivity, spontaneous lactation, and heightened libido have been observed in subjects who were members of the B.I.B (Bigger Is Bad) social movement.

The "Reset" formula has tested and proven to reverse all effects of S.E.X-013 and should be used with memory wipes when new instances of S.E.X-013 are found.

Discovery:

S.E.X-013 came to the organization's attention after a web crawler notified staff of a drastic increase in B.I.B leadership resignations following 25/12/2013. Investigation into the event revealed that an unknown individual or group had sent six instances of S.E.X-013 to several female leaders of the B.I.B movement. All leaders that had put the shirt on had experienced the far more extreme versions of S.E.X-013 effects. The organization acted quickly to secure all instances of S.E.X-013, undo all effects and change all resignation posts to "family leave" posts. With the exception of one higher ranked member of B.I.B, all affected individuals had their memories of the events wiped. The lone exception, Ms. Pandler, agreed to work with the organization in the future to prevent such events from occurring and should be considered a class Delta civilian agent.

Interviewed: Laura Pandler, President of the social awareness group B.I.B (Bigger is Bad)

Interviewer: Dr. Plentsiski, senior researcher and hostile group diplomat

<u>Foreword</u>: Interview was conducted after initial containment and reversal of S.E.X-013 effects were complete. During the investigation, it was discovered that Ms. Pandler was not only aware of the S.E.X organization's existence, but had been actively suppressing talk about it within B.I.B. It was decided by the lead investigator to possibly work with Ms. Pandler instead of wiping her memory.

Dr. Plentsiski: Good afternoon Ms. Pandler, I hope you are doing well after the reset treatment.

Ms. Pandler: (subject remains silent for 30 seconds) What on flat earth¹ makes you think I will trust a fat cow like you? You just tried to wipe out the majority of my life's work and now you're trying to get on my good side. Go get milked!

Dr. Plentsiski: I assure you Ms. Pandler, we are not against you and in fact we want to work specifically with you to prevent this sort of thing from ever happening again. We know you have been aware of our organization for quite some time. The fact you haven't had your memory wiped means our higher ups where not just impressed with that fact but also that you kept the secret of our organization from your fellow activists at B.I.B. Why is that?

Ms. Pandler: (subject is silent for 18 seconds and then sighs) Because, I saw some of the things you fat collectors are keeping. I hate to admit it, but I am not risking our glorious flat disk just cause I hate you sphere fuckers.

Dr. Plentsiski: So you understand that we are not here to destroy B.I.B, but simply to secure these out of the ordinary items?

Ms. Pandler: Yes, ya heifer.

Dr. Plentsiski: I see. Then we have a proposal for you, Ms. Pandler. We are very much interested in preventing future situations involving your awareness group, and we need someone inside your group to help us. We would provide you with a small degree of training to recognize out of the ordinary events, items or individuals. In return we will expect you to report to a handler every so often and report anything out of the ordinary in your group.

Ms. Pandler: You expect me to be a *snitch* for you fat-tit bitches?

Dr. Plentsiski: We would expect you to help us keep the peace. Your group has been known to have some more violent elements within it, and if those elements found out the truth behind the events of the last few days, they might take drastic and violent action against whoever they perceived to be responsible. Neither you or I want that. I know it may be hard to believe, but we have no intention of forcing anyone to have "fat-based flotation devices" as you have been known to publically call large breasts.

Ms. Pandler: (Ms. Pandler is silent for 10 seconds, appears to be thinking) Alright, I am onboard. But only because I already know what your deal is and have pretty much been doing your cover up work for you. Might as well get paid to do it.

Dr. Plentsiski:: Excellent

(the rest of the interview goes over details of the agreement, and were cut for brevity's sake)

Closing Statement: Ms.Pandler, while not always friendly towards staff, has continued to prove indispensable in preventing further anomalous scenarios from occurring within the B.I.B. group². Her attitudes towards large breasts, butts and the roundness of the earth have not at all changed.

- 1. Laura Pandler is also a know "flat earther." Believing not only that flat breasts are better but that the earth itself is flat.
- 2. To date, there have been number of such events reported. The B.I.B. organization appears to be a frequent target for unknown reasons.

Test: S.E.X-013-A

Test Recording::

Test run by: Dr. Pinny

Foreword: Delta-class-6348 was selected to wear S.E.X-013 due to her notable medical resistance to all known forms of over the counter breast enlargement products(including both and and as well as all milf-shake products). Delta-6348 is not aware of the organization, and a medical research front company was used to carry out this test. Delta-6348 believes she volunteered for a non invasive breast size increasing procedure.

Dr. Pinny: Dr. Pinny instructs Delta-6348 to wear an instance of S.E.X-013.

Delta-6348: Delta-6348 delays and then responds by donning the instance of S.E.X-013 provided. Delta-6348 apologizes for the delay, explaining she is not used to being referred to as Delta-6348.

Dr. Pinny: Dr. Pinny requests update on how Delta-6348 feels.

Delta-6348: Delta-6348 reports no physical changes or out of the ordinary feelings. Delta-6348 comments how S.E.X-013 seems "tight around the chest."

Dr. Pinny: Dr. Pinny requests Delta-6348 to continue to wear S.E.X-013 and update her to any changes.

Delta-6348: After about a minute and a half Delta-6348 lets out a sudden and surprised moan. Delta-6348's nipples begin to stiffen and are visible from beneath the S.E.X-013. After another thirty seconds Delta-6348's breasts begin to swell. This continues at a slow rate at first. Delta-6348 reports a tingling sensation and pressure on her chest with a mix of discomfort and pleasure.

Dr. Pinny: Dr. Pinny advises Delta-6348 to try to stay focused and continue to provide information on how she feels.

Delta-6348: Delta-6348's breast growth slows down and stops at an average c-cup size. After about 10 seconds subject's breasts expand rapidly to a ddd-cup, than rapidly again to a G-cup and finally one last rapid growth to a N-cup size. Each rapid change is accompanied by an audible "pumping" sound. Delta-6348 experiences several different emotions, from surprise, to joy to relief.

Closing Statement: Analysis of the shirt has shown promise. From what we can tell it doesn't work that differently from how Milf-shake does, just in a skin to fabric contact way. But there are some aspects of the change that are still unaccounted for after this test, namely the sound. Audio analysis shows that the sound is coming from S.E.X-013 itself and not the Delta-6348's breasts. The reason and mechanism for this are not yet understood.

In line with morality committee protocol, Delta-6348 was allowed to keep her post experiment breast size, but was given a memory wipe and false memories were implanted. Continued monitoring of Delta-6348 for long term effects has been approved and implementation of the mechanisms behind S.E.X-013 in over the counter products is fully intended.
