1. Information We Collect

We may collect the following categories of information:

a. Personal Information

- Name, email address, phone number

b. App and Device Information

- Device type, operating system, unique device identifiers
- IP address, app version, crash logs
- Usage behavior within the app

c. Optional User-Generated Content

- Content you submit within the app (such as profile details, comments, reviews)

2. How We Use Your Information

Your data is used to:

We may share your data only with:

 - **Law enforcement or legal authorities** if required to comply with a legal obligation
 - **Affiliated partners**, with your explicit consent

4. Data Retention and Security
