**Bugaboo Children's Consignment – Fall 2025 Event**

In consideration for the ability to participate in and earn profits from the Bugaboo Children's Consignment Fall 2025 Event (herein "Event"), the undersigned Consignor agrees to the following terms and conditions:

**Please initial each statement (do not check mark)**

\_\_\_\_\_ Consignor agrees that Bugaboo Children's Consignment is authorized to sell all items dropped off at the event. Bugaboo Children's Consignment reserves the right to reject or pull from the sales floor any item failing to meet its standards or which is deemed inappropriate.

\_\_\_\_\_ Consignor shall earn 65% of the Consignor's total sales; Bugaboo Children's Consignment shall earn 35% of the Consignor's total sales. Consignor earns additional 5% for each fulfilled volunteer shift up to 80%.

\_\_\_\_\_ Consignor acknowledges that Bugaboo Children's Consignment will not honor handwritten changes or scratch throughs on tags. All items will be sold for the original value marked on the tags. If the original value is unable to be determined by a visual inspection of the tag, Bugaboo Children's Consignment reserves the right to pull the item from the sales floor.

\_\_\_\_\_ Consignor must ensure that the information online is the exact information on the printed tags and is the correct information. The information on the PRINTED tag is the amount, discount option and donated option that the item will be sold for and NOT what displays online. If the consignor edits the item in any way, they MUST reprint the tag and replace the old tag with the newly printed (correct) tag.

\_\_\_\_\_ Consignor acknowledges that Bugaboo Children's Consignment will not sell items found without a tag. Any unclaimed items will be displayed on the "Lost and Found" table during pickup, and then donated to charity if not claimed.

\_\_\_\_\_ Consignor acknowledges that Bugaboo Children's Consignment provides for pickup of any unsold items on Saturday, September 20th 5pm-7pm and Sunday, September 21st, 2025 from 9am-11:30am. All items not picked up by 11:30am on Sunday become property of Bugaboo Children's Consignment and will be donated. Bugaboo Children's Consignment cannot hold items beyond this allotted time slot.

\_\_\_\_\_ Consignor herein covenants and agrees to indemnify, defend and hold harmless Bugaboo Children's Consignment, its owners, volunteers or participants, from and against all claims, costs and expenses resulting from any claim, demand or cause of action arising from any injury to any person or damage to property, occurring as a result of participation in the sale.

\_\_\_\_\_ Consignor agrees not to establish a seasonal consignment business, within a 50 mile radius of Bugaboo Children's Consignment, for a period of 24 months or two years.

\_\_\_\_\_ Consignor herein agrees to hold harmless Bugaboo Children's Consignment, its owners or volunteers, for any damage, theft or loss of any items to be consigned, including in the case of severe weather.

\_\_\_\_\_ Consignor herein warrants that Consignor is the owner of the items to be sold and has authority to sell said items; that each item is in good operating condition, normal wear and tear expected, and is not defective, broken, or damaged in any way; that any repairs made to an item have been made in accordance with the original manufacturer's warranty program; that each item complies with applicable laws; and ***that no item presented for sale is the subject of any pending or threatened recall noticed or other consumer protection action and that Consignor has checked each item on the website referenced in the Bugaboo Children's Consignment material – [www.cpsc.gov](http://www.cpsc.gov) – to confirm that items are in compliance.***
