Self-Reflection of Observed Area(s) to Grow:

I think I need to work on allowing the client to speak throughout the session, and I also struggle with the ending part of my sessions. I need to work on creating a natural flow to closing the session. I felt rushed in ending the session in this case, that was partially due to the recording, but it is something I struggle with in general. I also sometimes struggle with choosing appropriate counseling theories to service clients appropriately. It can be difficult for me to identify which approach to utilize based on the client's presenting concerns.
