January 15, 2019

The organizational meeting of the DeKalb County Central United School District Board of Education was held on Monday, January 15, 2019 beginning at 6:00 p.m., at the Central Administration Office, 3326 County Road 427, Waterloo, Indiana 46793. Under Miscellaneous, the President asked the Board, Administrators and the audience if they had any comments. Assistant Superintendent Lori Vaughn announced the Spelling Bee was going to be hosted by Waterloo Elementary on January 17, 2019. She said also on Thursday, the United Way was recognizing DeKalb Central for raising 10% more than last year in the fall fundraiser. These funds provide DeKalb Central families with help from the Bowen Center. Superintendent Steve Teders stated that in this Legislative session there are a lot of new bills being introduced so we could be seeing some changes come from the State. CFO, Steve Snider recognized Renee Dawson, Director of Transportation, Ashley Baron, Director of Food Service, and Gina Buhr, Director of Business Operations, all who were in attendance at the meeting. President Heather Krebs stated she had a Referendum Workshop on January 31, 2019 and on February 19, 2019 she would be at the State House in Indianapolis for a Legislative Liaison Meeting. She also

formally welcomed new Board Member Greg Lantz to the Board. Mr. Lantz brought a question as to the Staff to Student Ratio and how that is tracked with certified staff to classroom. Superintendent Teders responded that this information is constantly tracked and observed.

There being no further business to come before the Board, it was moved by Jay Baumgartner, seconded by Mark Eck, to adjourn the meeting at 7:29 p.m.
