Our goal is to have an honest, collaborative conversation about how public data is provided and utilized within our community. We will have three work-groups running simultaneously, each exploring the topic from a different perspective. Participants are invited to circulate and take the opportunity to learn from and contribute to all the groups. Our guiding questions throughout are:

What are the opportunities?

What are the challenges?

What next steps can we take to take advantage of the opportunities and overcome the challenges?

1. Open Data & Community Groups: Promoting Community Engagement

How can community groups make effective use of open data for advocacy and accountability? How can government engage and collaborate better with these groups? We will be looking at specific issues like homelessness and racial equity to ground our discussion.

2. Open Data & Policy-Making: Influencing the Policy Process

Where are the opportunities for citizens to use public data to influence policy? What can elected officials do to invite and support more data-driven dialogue? How can City staff better support both Council and citizens in the process?

3. Open Data & Local Media: Informing the Public Conversation

Why is public data important as a resource for local journalists to keep the community informed? How can the City best support the local media in giving journalists the hard data that they need to publish engaging and accurate reports? What role does the media play in facilitating the conversation between residents of the community and the City? How does the media influence this relationship?

In addition to the work-groups, we'll have a demo and conversation area hosted by City IT staff. Check out the City's public mapping tools, SimpliCity, the open data portal, and the new records request portal. This is also an opportunity to offer feedback on how the City can make data more accessible and more usable for you.
