MathSoc follows a modified version of Robert's Rules to help keep our meetings orderly. They prevent us from talking over each other. Please wait to be acknowledged before speaking. If you are not speaking please have your mic muted. For each speaking turn focus on a single point. Everyone has the right to speak. For a motion to be discussed it needs a "mover" and a "seconder".

If you wish to:

- Make a new point -> 1 in chat or raise one finger
- Reply as part of the ongoing conversation -> 2 in chat or raise two fingers
- Ask information about the speaking order, or relevant bylaws, or policies -> POI (Point of Inquiry)

- When you see someone else not following the speaking order -> POO (Point of Order)
- If you couldn't hear or need to take a break, etc. -> POP (Point of Personal Privilege)

Most motions at Council aren't controversial so we use a method of voting where you only need to explicitly vote if you wish to vote against a motion or abstain from voting. You can also write "Noted [Name]" to have your vote noted in the minutes. We can also use roll-call voting or ballot box voting if Council agrees to it or the Speaker decides it is appropriate.

The Speaker may estimate and set a time limit for any items. If time runs out on a motion, no new points will be taken except for motions to extend the discussion time or to defer making a decision to a future meeting. A vote on such a motion requires a simple majority to pass. If the motion to extend or defer fails, or no motion to extend or defer is moved and seconded, then we will immediately vote on any amendments on the floor and then will vote on the main motion.

5.2 Opt-in Fee for Alumni Board Game Rental — VPO Rondon, Councillor Bector

Whereas the MathSoc Office currently rents out board games to MathSoc fee-paying members. Whereas graduate students have expressed interest in being able to opt-in to fees so as to be able to rent out board games.

Whereas MathSoc currently has no stance on allowing or disallowing graduate students to opt-in to a fee to rent out board games, nor is there any indication of how long the term should be (lifetime vs termly). Be it resolved that Council will form a Committee to recommend a policy on this matter to Council. The Committee will be formed by the VPO, and Councillor Leung, and one Director appointed by Board. The Business Manager will sit on the Committee as a non-voting resource member.

Whereas the Pure Math Club's VP Pop is confident that the club will be able to sell another \$300 of pop, given that it is half-way through the term and pop sales are accelerating,
