**Motion** by Milender, second by Comnick, that the board be provided with a written breakdown of all income and expenses for all events hosted by MAT. **Motion carried.**

**Motion** by Stai, second by Williamson to approve the credit card bills. **Motion carried.**

**Motion** by Hooker, second by Stai to limit discussion to three (3) minutes per director and a one (1) minute rebuttal. **Motion carried with 2 opposed.**

**Motion** by Comnick, second by Carlson to approve minutes from the December Board meeting, Election meeting and December 28<sup>th</sup> special meeting. After discussion. **Motion Carried.**

**Motion** by Comnick, second by Stai to use roll call on the direction of one director and record requested roll call votes in the minutes by how each District voted. **Motion carried with 2 opposed.**

Graham Berg-Moberg presented the legislative report to the board at 9:30am.

**Motion** by Edge, second by Wells to approve MAT support on SF 1325/HF2791 currently in the legislature regarding townships having more control regarding ATV's and snowmobiles on township roads. **Motion carried.**

**Motion** by Hall, second by Stai to reappoint Director Edge to the MATIT Board. **Motion carried.**

Executive Director Krueger presented his report to the board regarding office renovations.

After discussion regarding the open seat in District 3. **Motion** by Bachmann, second by Edge to hold an in-person election at the district 3 meeting in August. **Motion carried with one opposed.**
