 - MnDOT/LRRB Clear Roads


2023 PLAN

Jonna Korpi	UMD	Asked if SLC is working w/ any others re planning the biochar aspects of the Woodland-Hartley BMP project because she's aware that a group has formed of interested entities in MN. It includes USDA, MN Farmers Union, U of MN toward the goal of increasing biochar production and use in MN (not just for stormwater). Ryan said Duluth's new BMP at Irving Park is also planned to include biochar (design by Barr). Ryan knows someone who owns forested land who is thinking of opening a local biochar manufacturing plant. Currently wood waste goes to Hibbing as biofuel but Minn Power only accepts occasionally. Carlton SWCD has a small mobile biochar maker.
