8. League Manager's Report - Dunya Cope (Smush)

- Recipient of The Quilt for August Molatov.
- Supporting members as they come forward needing additional support.
- o Behind the Back compliments started by Beaver.
- Working with Toxic to follow up with inactive skaters, and deciding whether BOD will make recommendations to change the OpDocs again to open up that timeline. Currently it says 90 days. Kid recommends that we discuss at the next League meeting, and reiterate the procedure and the importance.
- BOD reviewed Op Docs and amended the timeline for actionable items regarding LOA. E.g. if after 30 days no contact, reminders are sent with each dues cycle.
- BOD created a "reentry" fee that is comparable to the LOA rate to address the matter of when back dues are a barrier to returning.
- BOD reviewed and discussed via email the Inquiries from the League regarding part time participation. Decision of lowered inactive rate should be codified in the OP Docs.
