The following (*italicized* and **bold** text) is pretty much verbatim from the PERC site regarding Skill Assessments:

The Performance-Based Skill Assessment Evaluation is designed to standardize conditions under which the candidate demonstrates the performance of tasks to meet the requirements for PERC CETP Certification. The Skills Assessment should be supplemented with company policies and procedures related to each task being evaluated as needed.

- 1. The candidate has 12 months from the date of successfully passing the CETP Certification exam to train and successfully complete the tasks within the evaluation.
- 2. The affidavits and a final checklist are provided on the last two pages of the skills packet. Affidavits must be signed by both the candidate and the skill evaluator The final checklist must be fully completed within 12 months of passing the exam (Candidates may use this time to practice skills as often as necessary)

Make a copy for the training records when the skills assessment is completed for future audits Send the affidavit page and final checklist (last two pages) to the testing center within 12 months of passing the exam

3. All requirements and prerequisites must be met before certification will be granted.

Getting your Skill Assessment done

Over the years we have seen countless instances where students of the CETP curriculum have successfully taken CETP classes, taken and passed the exam, only to have their **actual certification never be completed**.

The reasons for this might include:

the skill assessment was not conducted for one reason or another including

- the employee left the company and the assessments were not followed up
- the company did not have a recognized Evaluator to process the Assessments
- the assessment completion were simply forgotten
- the skill assessments were conducted but the documentation was not submitted to PERC (at one time this was NPGA)
- a year came and went and the necessary paperwork to PERC became inadmissible, requiring the process to start anew

If you have a Skill Assessment that was not or has not been completed, <u>propaneandoiltraining.com</u> offers a series of skills assessments sessions available to anyone that has

- taken CETP classes
- completed the exam
- has yet to complete the final step skill assessment, evaluation and submission to the PERC council.

Generally, these sessions are no more than three hours in length, but any of our published Skill Assessment session notices will provide potential attendees with the estimated time to complete the Skill Assessment for that particular "Book".
