## Rules and Eligibility

I hereby apply as an entrant into the 2026 Miss Buckingham Pageant and acknowledge and agree to the following terms:

1. I am between the ages of **3 years and 24 years** as of March 14, 2026.
2. I am **not married**, have **never been married and have never had a marriage annulled**. I have **never given birth to a child** and I am **not currently pregnant** nor am I a parent. If any of these conditions change, I will notify my Pageant Director immediately and understand this will affect my eligibility.
3. I am of good health, was born female and have good moral character.
4. I am currently a legal resident of **Buckingham County and have been for at least six (6) months** immediately prior to March 14, 2026. (Although I may attend a college or university elsewhere). I may be required to show proof of residency.
5. I unconditionally and forever release any claim against Miss Buckingham Pageant and its committee for any use of my name, or biography in connection with the Miss Buckingham Pageant, including promotional and advertising materials.
6. I understand and agree that the Miss Buckingham Pageant Committee shall determine all issues in regard to eligibility and agree to abide by that determination both as to myself and other applicants.
7. I understand that I am **free to withdraw from the competition at any time, but under no circumstances will I be entitled to a refund that my sponsor(s) or I have paid**. There will be absolutely no exceptions to this policy.
8. I understand good sportsmanship at, during and after the pageant is crucial. I understand that a violation of good sportsmanship, by my audience, or myself, is at the discretion of the Pageant Committee and will **result in disqualification** and/or relinquishing of title no matter the age of the contestant.
9. All outfits must be in good taste and age appropriate. Any questions will be discussed with the pageant director prior to the pageant. If the pageant director feels the outfit is not appropriate, I will abide by that decision.

10. Trophies and/or crown will be awarded in each category to the winner, the first and second runner ups only.
11. Pageant winners will participate in Auxiliary events.
12. Attending practice sessions are mandatory in order to participate.
13. I understand that **no judging information will be given out at any time**, and that I will be judged on the following: Personality, Poise, Smile, Stage Appearance, and personal information given.
14. I understand if a category has less than two (2) entrants, that category may not be held and my entrance fees and ads may be refunded.
15. Contestants must never have been the “title holder” for the age/division in which they are currently participating.

Failure of the winning contestant to comply with any of the terms, provisions, restrictions or obligations hereof shall, at the options of the Pageant Committee, result in the entrant’s disqualification, loss of title and return of any and all prizes awarded.
