

2023 Summer Blended Health

EHS provides a summer class for Edina Public School students who are interested in taking a blended Health class. This course is designed for self-motivated students who are willing to do independent work during the summer. Students will have a combination of face-to-face learning, and online work to complete to earn the credit. Students are expected to participate in class activities and bring a computer.

Face to face sessions are June 7th and June 15th from 1:30-3:30 pm.

Dates for the whole course are June 7th- August 11th.

LOGISTICS

IN-PERSON SESSIONS

Rooms N306 and N307, Edina HS

- **Students must attend the in-person sessions listed above.** The remainder of the course will be asynchronous.

ONLINE LEARNING SESSIONS (Asynchronous)

- June 7th - August 11th
- Students MUST have consistent internet access throughout the summer.

ELIGIBILITY: Incoming 9th - 12th grade EHS students. This class counts as *one of the seven first semester classes* students enroll in for the 2023-24 school year.

NOTE: Students cannot take more than one EHS course in a summer session. They must choose either Personal Wellness or Health, but not both.

GRADING: Students will be assigned a letter grade that will appear on their first semester transcript for school-year 2023-24. Pass/Fail is not an option for Summer Blended Health.

DIRECTIONS FOR ENROLLMENT: *Students must register during the EHS 2023-2024 course registration period, Feb 9-24, 2023.*

Step 1: Register for a Semester 1 Student Prep in Infinite Campus during the registration period. Doing this allows us to ensure the summer course counts as one of your seven 1st semester courses.

Step 2: Complete the google [document](#) to register for the course.

TRANSPORTATION: To be determined based on enrollment.

REQUIREMENTS FOR EARNING CREDIT

1. **Attendance** is required for credit. Due to the compact nature of curriculum offered over summer, **students missing in person for any reason will be dismissed from summer school.** There are no exceptions. This policy is not meant to be punitive, but is a reality in earning a credit for graduation in this short period of time. **Students must have access to CONSISTENT internet access throughout the summer.**

2. **Coursework:** All assignments must be completed to the satisfaction of the teacher. Students should expect 5-7 hours of homework each week. This includes all activities and Schoology assignments. Grades are listed on the transcript as A-F and will be added to the transcript in fall of 2023. Coursework must be fully completed by the last day of the course, August 11th. **Coursework will not be carried over into the next school year.** Students who do not finish their course will be assigned a grade of F and will need to meet with their EHS counselor to schedule the course into their schedule the following year.

3. **Behavior Expectations:** Follow all rules and expectations of the high school, including showing respect to peers and staff. Any conduct issues may result in removal from the summer course. Any suspensions will result in automatic removal from the summer program.
