Context & Overview

Staged a coup to seize power over the D2 Education Council
Ousted as President of D2 Education Council by a vote of No Confidence
Led encouraged and maintained a toxic, racist, violent culture at CEC2
Encourages violence against Black Mothers and Students of Color
Excluded Black parents from representation on the NYSED Integration team
Designed an integration plan that excluded schools w/ significant numbers of Black & Latinx students
Passionately Opposes Anti-racism practices
Said that homelessness is the same as gang violence at a public event

- According to Southern Poverty Law Center, “Moms for Liberty and its nationwide chapters combat what they consider the “woke indoctrination” of children by advocating for book bans in school libraries and endorsing candidates for public office that align with the group's views. They also use their multiple social media platforms to target teachers and school officials, advocate for the abolition of the Department of Education, advance a conspiracy propaganda, and spread hateful imagery and rhetoric against the LGBTQ community.” ([source](#))

 - When Maud was president of CECD2 in 2020, there were frequent impasses, overt racist behavior on the council, and critiques of all orgs or people with different POV.

Maud Maron's Racist Receipts

- #FraudMaud is a founder & Vice-President of Anti-Integration Group PLACENYC, an org which has endorsed political candidates affiliated with QAnon, xenophobia, and who supported the Capital Insurrection in January 2021.
- #FraudMaud characterizes the idea of anti-racism as "a benign-sounding but chilling doctrine."
- #FraudMaud attempts to portray herself as a "liberal," yet time and again she has fought against organizations like Teens Take Charge, a youth-led group that fights for educational equity, and recently targeted a youth activist of color for raising allegations of racism with her political campaign.
- #FraudMaud published an op-ed in response to her critics, identifying herself as a public defender and a liberal bona fide. She states that anti-racism is what invites discrimination, and then characterizes education equity advocates as race-obsessed.
- #FraudMaud's own co-workers the Black Attorneys of Legal Aid and The Legal Aid Society, Maron's employer, both issued statements condemning Maron's brand of liberal racism.
