

CleanSheet Creator Club Program Terms and Conditions

1. Eligibility

1.1. The CleanSheet Creator Club Program (the "Program") is exclusively available to users of the Meta Quest platform who are at least 13 years old and have a valid social media account on YouTube, TikTok, Facebook, or Instagram.

1.2. Employees, contractors, and affiliates of INCISIV Ltd ("Company") and their immediate family members are not eligible to participate in the Program.

2. How to Participate

2.1. To participate in the Program, capture in-game content using the Company's content capture tools on CleanSheet Soccer available on Meta Quest and post the content on YouTube, TikTok, Facebook, or Instagram using the hashtag #CleanSheetVR.

2.2. Content must be original and must not infringe on any third-party rights or violate any social media platform's terms of service.

2.3. Videos must be posted on YouTube, TikTok, Facebook, or Instagram after the Program's start date of August 28, 2024. Videos posted before this date are not eligible for participation or prizes.

3. Content Requirements

3.1. The content you post must be relevant to the Program and adhere to all community guidelines of the social media platforms where it is shared.

3.2. Content should not contain any illegal activities, hate speech, violence, or other content deemed inappropriate by the Company.

4. Prize Structure

4.1. Prizes are awarded based on the number of views your content accumulates on YouTube, TikTok, Facebook, or Instagram. Specific view thresholds and corresponding prizes are outlined below:

- 1000 views or above - 1 Meta Quest key to Amethyst Gloves
- 10,000 views or above - 1 Meta Quest key to Triball Ball
- 100,000 views or above - 1 Meta Quest key to Frostbreaker Gloves

4.2. Prizes are distributed solely for the Meta Quest platform and are subject to availability. The Company reserves the right to substitute prizes of equal or greater value. The Company also reserves the right to withhold or cancel prizes at its discretion.

5. Prize Distribution

5.1. Winners will be notified via direct message on the social media platform where they posted their content within 14 days of reaching the view threshold.

5.2. Prizes are awarded to one account at a time. Each account is eligible for one prize per view threshold reached.

5.3. Winners must respond within 7 days of notification to claim their prize. Failure to respond within this period may result in forfeiture of the prize.

5.4. Prizes will be distributed for the Meta Quest platform and delivered to the address provided by the winner. The Company is not responsible for any lost or undelivered prizes.

6. Rights and Ownership

6.1. By participating, you grant the Company a non-exclusive, royalty-free, worldwide license to use, reproduce, and display your content for promotional purposes.

6.2. All content remains your property, but you agree to grant the Company the right to use it as described above.

7. Disqualification

7.1. The Company reserves the right to disqualify any participant who violates these Terms and Conditions or engages in fraudulent or deceptive practices.

8. Limitation of Liability

8.1. The Company is not responsible for any technical issues, errors, or malfunctions that may affect your participation in the Program or receipt of prizes.

8.2. The Company is not liable for any indirect, incidental, or consequential damages arising from participation in the Program or the use of any prize.

9. Termination of the Program

9.1. The Company reserves the right to modify, suspend, or terminate the Program at any time, at its sole discretion. Such action will nullify and void any future or current entries.

9.2. In the event of termination, the Company will have no obligation to deliver any prizes, and participants will have no recourse against the Company.

10. Prize Restrictions

10.1. Prizes cannot be resold, repurposed, or transferred to any other individual or entity. The awarded prizes are intended solely for the recipient of the award.

11. Changes to Terms

11.1. The Company reserves the right to modify or terminate the Program at any time, including these Terms and Conditions, without prior notice.

12. Governing Law

12.1. These Terms and Conditions are governed by and construed in accordance with the laws of the United Kingdom, without regard to its conflict of laws principles.
