

Actions highlighted as green become our "bright spots" to share and brag to the community. Amber (yellow) identified actions which are in progress but maybe not complete. Red indicates the action is not in process and needs to be addressed. Blue indicates an action that has been dropped, replaced by another action item found to be more effective.
