Background/Introduction

- 1. Small-scale fisheries and aquaculture in CARICOM/CRFM States make a valuable contribution to poverty alleviation, food and nutrition security, employment and income generation, economic growth, and social stability. They provide livelihood security for members of society, including women and youth.
- 2. The purpose of the *Caribbean Small-scale Fisheries and Aquaculture Forum* is to highlight the critical role of the sector in contributing to the region's social, economic, environmental, and climate resilience.
- 3. This session also seeks to provide an update on the implementation status of the <u>CNFO/CRFM Small-Scale Fisheries Action Plan 2023-2025: Contributing to Achieving the 25% Reduction by 2025 in the Caribbean Community Food Import Bill.</u> It will focus on challenges and opportunities in improving the contribution of small-scale fisheries and aquaculture (SSF/A) to reducing the region's food import bill.
- 4. The session will also highlight the role of insurance in increasing the resilience of the small-scale fisheries and aquaculture sector and protecting livelihoods.
- 5. Under the CARICOM Agri-Food Systems Strategy, fish is one of the commodities being targeted for increased regional production. The CNFO/CRFM Small-Scale Fisheries Action Plan (2023-2025) aims to address challenges and seize opportunities to make a significant contribution to the CARICOM Heads of Government commitment to reducing the region's food import bill by 25% by 2025 within the context of the Caribbean Community Common Fisheries Policy (CCCFP) and its supporting protocols, as well as the CRFM Strategic Plan 2022 2030. The Plan is well aligned with the Protocol to the Caribbean Community Common Fisheries Policy on Aquatic Foods as a Strategic

- Resource for Food and Nutrition Security, which was adopted by the 17th Regular Meeting of the CRFM Ministerial Council in 2023.
- 6. Towards building resilience in the Caribbean fisheries and aquaculture sector, it is well recognised that there is a need to prioritize efforts to provide improved access to financing and adequate insurance instruments and coverage to protect all interests in the sector. This is especially due to the impacts of accelerated climate change, extreme weather events, rising surface and sea temperatures, ocean acidification, and intense and reduced rainfall on the sector.
- 7. In 2019, CCRIF SPC (formerly the Caribbean Catastrophe Risk Insurance Facility) and CRFM signed a Memorandum of Understanding (MOU), to provide a framework for enhancing the capacity for disaster risk management and resilience in the wider Caribbean Region, with specific emphasis on the fisheries and aquaculture (including mariculture) sector.
- 8. The MOU focuses on collaboration through the Caribbean Oceans and Aquaculture Sustainability (COAST) initiative with other partners to reduce the risk that climate change poses to food and nutrition security in the Caribbean, and to mitigate climate change impacts on sustainable food production and food sovereignty.

Objectives:

The objectives of the Forum are to:

- Provide a space for small-scale fishers to engage with CRFM, Member States' representatives, other stakeholders, and partners in matters of key importance to the sector, surrounding the central themes of climate change, food security, and sustainable livelihoods, including the potential future roles of fishers in harvesting Sargassum.
- Raise awareness about the CNFO/CRFM Small-Scale Fisheries Action Plan aimed at contributing to CARICOM's 25 X 2025 vision, and the challenges and opportunities with achieving its objectives of:
 - o contributing to food security and food sovereignty;
 - o strengthening/developing sustainable and resilient small-scale fisheries value chains;
 - o mainstreaming gender along the fisheries value chain, and creating opportunities for the participation of women and youth; and
 - o improving livelihood opportunities along the value chains by increasing access to financing and facilitating capacity building.
- Promote insurance as a means of improving climate resilience in the fisheries and aquaculture sector, highlighting the COAST initiative.
