Dress Code: Semi-Formal (**Violations will result in denied entry**)

- Midriffs should not be exposed (shall not show belly button).
- Skirts and dresses must be fingertip length.
- Undergarments should be covered and should not be visible.
- All alterations must be permanent. – No quick fixes at the door.
- Appropriate footwear must be worn at all times. No flip flops.
- You may not change your clothes to another outfit when you enter the dance.

Those who attend the dance are expected to behave in a mature, dignified manner. The DJ has been instructed to play radio edited versions of songs. If your request does not fit this criteria, it will not be played. No dancing that implies sexual activity or dancing that puts the safety of others at risk is allowed. Rowdiness and horseplay or misbehavior as deemed by any chaperone will **not** be tolerated. **Any student with a history of behavioral misconduct, as reported by the dean will not be allowed to purchase a ticket or will have their ticket refunded, along with permittance to the dance being denied.**

You will not attend the dance if you currently have symptoms or have been in contact with anyone with a confirmed Covid-19 diagnosis in the last 14 days. The undersigned agrees that the Student will comply with any safety or health related rules, terms, or conditions for participation in the dance.

Coral Academy, along with its Student Council, holds no liability for injuries occurring due to activities in the dance. All participation in games or events at the dance is partaken with full responsibility and risk of the dance attendee and/or legal guardian.

Anyone unable to comply with the above policies will be denied admission, could be asked to leave, parents contacted, and could result in disciplinary actions such as detention and/or suspension. Students may not leave before 8:30 PM. Parents picking up before 8:30 PM must come to chaperones at entrance and show ID. Students who leave the dance for any reason will not be allowed to re-enter the dance. Coral Academy reserves the right to summarily eject any objectionable person(s) from the facility, both before and during the event. Coral Academy retains the right to deny Student's attendance or participation in the dance if the School determines that such attendance or participation is an undue risk to Student or others. Parents/Guardians are not allowed in the dance, unless they are a background checked volunteer who is chaperoning. Pick up will happen at the MPR gate.
