


Hey. I'm Yitrium/Lucifer/Luci/Frankie/Jester0FTheM00N [or at least that's what you'll know from this stream or post as I have decided to remain anonymous for the time being **[Not anymore for the record lmao]**]. I am an Ex wife of Donnie's and I would like to talk about how I was treated and how I was used from what I both can remember and grab screenshots of. I am also an Ex Slideshow Commentary Community member [Now an independent commentator]. This won't be a particularly long testimony but during the time I was dating him [which was nearly a year for the record] it was a very emotionally taxing relationship. With me doing a majority of the emotional labour and leg work. He was also very emotionally manipulative [bordering on abusive] towards me and I will further detail this as this document continues. There's more he's done to me but I'll really only be talking about this if only because I feel more comfortable doing so.

On April 18th 2025, Chuuli had released a video detailing her experiences with Avi Haltmann a former Slideshow Commentator who was ousted for Abusing, Grooming and Lying about Chuuli [specifically claiming he was abused by Chuuli and that she had threatened him with his dox]. During this time I had a DM conversation with Donnie that would then suddenly spiral out of control when he broke down. Now something I want to make explicitly clear is that while out of context this just looks like someone who's simply going through it. IT'S NOT. And upon retrospection and analyzing how he treated me in particular as well as the treatment and hell he put Deed and Silver through [especially towards Deed] this was absolutely intentional. You see Donnie has/had a habit of constantly wanting validation for his "trauma" [I put this in quotes because he is a pathological liar] or really anything that even slightly or mildly upset him. To put it bluntly, it was suffocating and many of these instances lead to me being in emotional distress and being forced to rawdog my own mental breakdowns whilst having to comfort him. Now without any further delay let's get into these screenshots regarding this particular incident.



As detailed earlier. This was something he did very often around this time and even earlier on [hell pretty much as long as I've known him]. "What if I'm a bad person and I don't know it?". I used to tell him that'd be impossible because y'know for one he was my partner but also because I thought if he really was as "bad" as he was, he wouldn't have felt any remorse or had that worry at all. BOY WAS I FUCKIN' WRONG WASN'T I???? Considering his behaviours that were detailed in Deed and Silver's video [specifically part 2] though, this now reads to me less like being anxious or anything of that sort and more like his guilty conscience getting the best of him. Something that would happen constantly as a matter of fact, something he would label as "Moral OCD" which was yet another thing he would self-diagnose himself with. Fan-fucking-tastic Donnie. Now something I should make really clear here too, I didn't know about what he had done to Deed since this was well before this situation between Deed and Donnie had become public. And to restate, I had no reason to think at the time this was what he was actually doing as opposed to worrying he'd become a bad person or that he was the entire time. Because I absolutely empathized with him since I had similar worries as I was very quickly rising up the ranks socially in the SCC at the time but also in positions of power. Specifically with me gaining control of the wiki as well as not even a month later becoming a moderator in the SCC courthouse. And those who know me can and will attest to how seriously I took those responsibilities at the time.

Now. Onto the next screenshot.




This first message is more of the same. And what I'm referring to as far as Chuuli's forgiveness is concerned, at the time was from a courthouse call she had with the wider community correcting the record about what had really gone down concerning Avi. And Donnie had made a direct apology towards her in that call for believing Avi's lies to which like stated in my message she had accepted under the impression he had no reason to not believe Avi. With what we know now of course, I wouldn't be all that surprised if Chuuli revokes that forgiveness now given Deed had revealed that Donnie knew about Avi's propensity to be a vile sex pest since they had both directly talked about it with each other's DMs as detailed in Deed and Silver's video.

Now as for the whole "I don't count as a victim of Kayden. I don't count" thing. Donnie had started making claims about Kayden around March of 2025 when more information was made privy about how Kayden was being really fucking creepy towards Chuuli and even going as far as to sexually harass her when she was 14/15 on stream. The claims Donnie made specifically was that Kayden also acted this way towards Donnie when he was a minor. He melted down about this since he didn't have evidence because this was during the skype days. Or at least that was the reasoning he wanted to portray. While I won't outright

deny that Kayden was a creepy bastard towards people when they were minors talking about sexual topics and sending porn. I am certainly a fuck ton more skeptical now given Donnie has now been making claims that Silver had been inappropriate towards him when he was a minor and has also made a numerad of other false claims of this nature. Of course I at the time believed him because I personally am of the philosophy to believe the victims because I've personally been victimized in similar ways and I know how shitty it feels to not be believed by anybody. And he fucking weaponized my empathy and love for him, towards Silver and furthermore abused it to gain more validation for himself even though he would've had a lot of it from me anyway. But hey I guess I can just go fuck myself for having empathy and compassion for you as my at the time partner right Donnie?

FUCK YOU. A THOUSAND TIMES, FUCK **YOU**.

Onto the next screenshot.



Again more shit I at the time saw as “going through it” as well as seeing it as him feeling a level of survivor’s guilt due to being a part of Rachel’s [Rae Kohai] group. But again given he was still associating with Rachel back in 2020 and lied to Deed about her talking massive shit about Deed. Stating that Rachel never spoke about Deed. The fucked up thing is that even with his need to be validated and coddled he knows what he’s done. He knows exactly what he’s done and he really only began to talk about this when a lot of stuff started happening in the community where lots of ex cloud palace members were being thrown into pits of acid [figuratively of course]. But again this was him taking advantage of the empathy I gave towards him because I know how it felt to feel guilty over shit talking and participating in toxic server culture.

Specifically Souvlivvy’s private server LWMG [Lizard Wizard Money Gang]. Where I’ll admit I definitely participated in shit talking in vcs and went along with what Olivia had pulled.


I should note I am a victim of hers as well and she did something very similar to me to what Donnie has here which I will detail later. While we’re still here on this subject in question. Part of me wonders if Donnie took my guilt from being around Olivia and her server and

participating in the toxic culture and tried to make it his own via the cloud palace. My experiences video with Olivia will be linked here:

Now as for the “Publicly, privately she/her” comment I should note that this was also roughly around the time when we had figured out Rachel had been hiding on an account known as Soonsoonstumpy posting videos on youtube specifically on a channel under that same name. Her pronouns on this account were listed as they/them though I didn’t know if that was just a public face vs private face sorta deal. So when I saw him refer to Rachel as “Shedevil” I was confused since at the time I had believed her to be going by strictly they/them. Donnie to my knowledge has not spoken to Rachel after being cut off.

As for those last parts of those messages since he was nonverbal during the call at this point I don’t quite recall what I asked him so onto the next screenshot.



This one.

THIS FUCKING **ONE**

See this hurts particularly deep considering it's a part of my heart that's still unfortunately bleeding to this day.

So for those wondering. The Ex he's referring to was somebody I dated in highschool, around grade 11. To make it easy I'll just refer to this person as "X". For the long and short of it "X" was incredibly abusive towards me in almost every way but financially, physically and sexually. Everytime I would attempt to leave the relationship because I was almost constantly either getting into arguments or being mistreated she would use her life as a bargaining chip and would threaten to kill herself. Keeping me up. 2 to 3 days at a time through either constant beration through messages or calling me. One day she put me in a random group chat and it was where I was introduced to her "boyfriend", despite ***still dating me***... Now he didn't talk much but my spidey senses were fucking going off telling me that something was *horribly wrong*. And lo and behold my intuition was right because I heard his voice and I asked his age. 13. 13 years old and was being preyed on by this person. I told him to run away from her. And then I broke up with her and she rage quit the call. And the proceeding year was hell. I was harassed by her irls and her online friends constantly to the point where I couldn't even so much as use my at the time name on any places like instagram for instance. It was hell because that abuse and such was vehemently denied and reversed onto me being the evil one. Eventually with time I was able to prove that I was innocent. But the trauma I had gotten from it was irreparable. And it was made even worse when in May of 2022 she killed herself. I got blamed for it and again *never heard the fucking end of it* from those who had still stuck by her.

Now I know that was a metric fuck ton but please put a pin in this.

I told him about this and why it's the reason I have such a big trigger about serious discussions and such of suicide.

Given what has been revealed about how Donnie is absolutely capable of trying to use others' trauma for any kind of personal gain... He fucking used mine in order to validate his own fucked up delusions. Genuinely donnie why??? Why the fuck did you do this to me????? Why? Fucking why?!!

Oh really donnie you don't want to be like my ex????? You reaaaaaaaaally don't wanna be like her????? Well congratu-fucking-lations you motherfucker you did. You would make me take care of you fucking constantly even when I was actively breaking down. Fuck you. Fuck you you fucking fuck. You made me wonder everytime I woke up or went to bed if you were going to be dead. You made me worry. You fucking used me.

Worst of all you did this TWO FUCKING DAYS BEFORE I CAME OUT ABOUT WHAT OLIVIA HAD DONE TO ME YOU PIECE OF SHIT.


I fucking loved you. I bent over fucking backwards for you. I spent hours of my life with you. I wanted to spend the rest of my life with you.

And when I eventually did confront you about this during me confronting the *HEINOUS SHIT YOU SAID ABOUT R/N*. You apologised. The problem was however. I had to downplay the severity of how what you pulled in this particular conversation hurt me. I *distinctly* remember telling you I held off on confronting you because *you were struggling*. I again put *your fucking needs* before mine, like I *always* had to...

I revoke that forgiveness entirely because given what you pulled with deed and a lot of others that I've seen. I bet you didn't apologize because you were actually remorseful. No. You only fucking apologized to me because you were caught.

Now to send this off because I know a certain somebody who's running a defense campaign is going to see this. Your partner is a liar. Your partner is a fucking monster. A fucking wolf in sheep's clothing. And now. Now I will prove that Donnie is still lying about being a system.
