#### Withdrawal Deadline: March 1, 2024

To withdraw, you must complete the <u>Global Learning Request to Withdraw Form</u> **before March 1st, 2024** to avoid financial penalties beyond the \$200 non-refundable application fee. **For more information on withdrawal penalties view below.** 

#### **Withdrawal Penalties**

Withdrawal Date	What you Owe	Why
Before March 1, 2024	\$200 Application Fee	This fee covers the administrative costs involved with processing your application and holds your space in the program.  If you need to withdraw due to financial reasons, you can state this in your withdrawal email and we will waive the fee until March 1, 2024.
On or After March 1, 2024	Global Learning Program Fee (GLPF), due in August. Note: this does not include tuition and campus fees.	Global Learning must commit to pay for your program participation at this date. The fees are not refundable to us, and therefore are not refundable to you.

<sup>\*</sup>All financial terms and agreements are outlined in our <u>Global Internship Financial Terms and Agreements</u> document, which is required to be signed by the participant as part of the Global Internship application.

<sup>\*\*</sup> If you withdraw from the Global Internship program, you will also be dropped from the corresponding courses.
