

The Michigan Merit Curriculum (MMC) graduation requirements are intended to be flexible, allowing students to create an individualized diploma pathway. This flexibility is especially important for students who may benefit from waving certain MMC credits with a PC. Ideally, PC teams would use the EDP as a guide, removing unnecessary MMC credits based on unique student needs and post-school plans. This session will review the MMC requirements as needed before digging into the personal curriculum options and suggested use. Section 504 of the Rehabilitation Act of 1973 is a civil rights law that prohibits discrimination against individuals with disabilities. Section 504 ensures that a child with a disability has equal access to an education. The child may receive accommodations and modifications even if he or she does not qualify for special education. Any school or program receiving federal funds must follow this law.
