Obvious thought has been put into the use of diction (word choice) and syntax (sentence structure) to establish comedic tone and pacing. Techniques are labeled accurately on the script, but could be more varied.	Comedic tone and pacing established through the writer's sophisticated use of diction and syntax, as well as comedic techniques (see Comedy Toolbox). Recording / Performance	Recording / Performance shows little – if any – planning or practice. No clear explanation of comedic influences or process. Create your own criteria: Sweat	Performer was consistently devoid of sweat or any visual external discomfort. Performer maintained an authentically casual demeanor with no signs of inner panic or anxiety.	Performer is sweating around typically sweaty areas, such as armpits and wrists, but not enough for it to be immediately noticeable. Only small signs of performer's discomfort and anxiety show through the routine.	Performer is significantly and noticeably sweaty. Hair and face glisten in the light, and skin is wet to the touch. Shaking hands and occasional, non-intrusive stuttering imply heavy anxiety and nerves throughout the performance, but do not interfere with its quality.	Performer is totally and visibly drenched in sweat, including on hair, face and clothing in the form of dark marks. A tangible air of nerves and anxiety is obvious through visual appearance, but such nerves only extend to the visual aspect of the routine.
