Edina Community Ed's Kids Club program offers a fun, engaging environment for your child that will enrich your child's experience in Edina Public Schools. Our summer program offers a balance between structured activities, supervised free choice and field trips to a variety of locations. We provide a safe place for children to develop friendships and grow in confidence, independence and respect for themselves and others.

Registration Information

Lottery registration is open Tuesday, February 10, 8:00 am to Monday, February 23, 11:59 pm.

Contract requests will be accepted during this two-week window. Contracts must be requested during this window of time to be included in the lottery.

If more contracts are requested than available at a specific site, a random computerized lottery will be held. There will be no preference given for when the contract request was submitted.

Registration Fee: \$50/contract, non-refundable

Field Trip Fee: \$170/contract, non-refundable

Daily fee (7am - 5pm): \$60.70/day

Daily fee (7am - 6pm): \$66.95/day

Daily Fees include afternoon snack and all program materials, and supplies. Children are required to bring a bag lunch each day. Two t-shirts are provided with registration.

- Three, four or five days per week consistent schedule contracts are available. These days remain the same for the duration of the contract.
- Six week minimum commitment is required. You choose your weeks!
 - Select your weeks (at least 6 of the 10 available) at the time of registration.
 - Weeks do not need to be consecutive.

Payment Information

Edina Kids Club requires payment by VISA, Discover, American Express and MasterCard credit/debit cards. Your credit/debit card account will be charged on the 1st business day of each month for the contracted amount due for that month.

Be sure to set up your online account login and password. We send out monthly invoices via e-mail approximately 3 days prior to charging your card on file. All financial and scheduling information is available by accessing our website and visiting the online accounts section at edinacommunityed.com/register.

Registration	\$50 per contract	Non-refundable after the contract has been accepted.
Field Trip Fee	\$170 per contract	Non-refundable after the contract has been accepted.
T-shirt fee	\$10, Please indicate with your registration if you would like to purchase an additional shirt.	Two Kids Club summer t-shirts are included with each child's registration. Children are required to wear a Kids Club t-shirt for any event that leaves EPS school grounds. If a child does not bring their t-shirt for an offsite event, they may opt out and remain onsite, or they will be given a new t-shirt and your account will be billed accordingly.
Schedule Changes & Contract Cancellation	\$15 per written request (cannot cancel individual days for credit)	10 business days prior to the effective date. Parents will receive an email confirmation. Change fees are per request, per child. Days cannot be cancelled if it results in dropping below the 3-day per week, 6-week minimum summer commitment.
Summer Commitment Deadline	\$25 withdrawal fee plus \$546.30 per contract	Withdrawing from the program after the May 1, 11:59 pm deadline will result in fees. \$546.30 is equivalent to 50% of the 3-day per week, 6-week minimum summer commitment.
Late Pick Up Fee	5 -15 minutes= \$15 /day over 15 minutes late =\$1 per minute additional charge/day	Children not picked up by their contract end time will incur a \$15 late fee per day. Children picked up 15 minutes or more late will be charged an additional \$1 per minute fee.

Contract Terms

1. I understand that my child cannot begin the program until I receive confirmation of contract approval from Kids Club (hereafter referred to as the program) and the registration fee is paid.
2. I understand my credit card will be charged monthly for the contracted amount due the 1st business day of each month. I understand that I will be charged a late payment fee of \$20.00 for credit/debit card that is declined for any reason. For registrations approved after the 1st of the month, tuition and registration fees will be charged at the time of registration.
3. I understand that monthly invoices are sent via e-mail approximately three (3) days prior to charging my card on file. My account information is available to view 24 hours per day and all financial and schedule information pertaining to my child can be found online at edina.ce.eleyo.com.
4. I understand that my enrollment may be suspended and/or terminated if the program is unsuccessful in collecting my monthly tuition.
5. I understand that delayed entry into the Kids Club Programs or suspension of care may occur if I fail to disclose any conditions or specific needs that affect my child's ability to participate in the program safely.
6. I understand that if my child is picked up after agreed contract pick up time my account will be charged a \$15 late fee per occurrence. I understand if my child is picked up more than 15 minutes late then my account will be charged an additional \$1 per minute.
7. I understand all requests for a schedule change/contract cancellation must be in writing and I will be charged a \$15 processing fee per written notification. I understand requests need to be received at least TEN (10) business days prior to the effective date of the schedule change/contract cancellation, and I will receive confirmation of a schedule change/contract cancellation via email when complete.
8. I understand that withdrawing from the program after the May 1, 11:59 pm deadline will result in a withdrawal fee of \$25 plus \$546.30 per contract. \$46.30 is equivalent to 50% of the 3-day per week, 6-week minimum summer commitment.
9. I understand that I am unable to cancel individual days for credit. No reductions in fees will be made for absences.
10. I agree to pay the following fees (if applicable):
 - Summer Registration: \$50 registration fee per contract.
 - Field Trip Fee: \$170 fee per contract.
 - Late Payment: \$20 per month for credit card decline for any reason.
 - Late Pick-Up: \$15 fee plus an additional charge of \$1 per minute will be applied after 15 minutes.
 - Schedule change/contract cancellation: \$15 per written notice.
11. I agree to list two (2) people (other than parent/guardian) on this contract who are authorized to pick up my child and/or take responsibility for my child in the case of illness/emergency (must be 16 years of age or older). I understand that I must enter contact information in the system for all people I would like listed as authorized to pick up my child from the program.

12. I give my consent for my child to be included in photos and videos of program activities that may be used in school district publicity such as newsletters, brochures, websites and videos, and any media coverage such as newspapers or television. If I do not give consent, it is my responsibility to notify the Kids Club main office in writing or email them at ecc.kidsclub@edinaschools.org.

13. I give my consent for my child to participate in program field trips. I understand that program staff will supervise all field trips.

14. I give my consent to an exchange of my child's information between the program staff and any other necessary Edina Public School staff when it serves a legitimate interest to my child.

15. I give my consent for my child to leave the program care with an Edina Public Schools employee/hired instructor during programming if needed. Examples include, but are not limited to: a. Finishing an assessment b. Assisting in the classroom c. Music lesson d. excitEd!

16. I give my consent to the program to make whatever emergency (i.e. first aid, disaster evacuation, etc.) measures are judged necessary for the care and protection of my child while under the supervision of the program staff.

17. I understand that in case of a medical emergency, my child will be transported to the nearest hospital by ambulance if the local emergency resource (police or rescue squad) deems it necessary. I will be responsible for the cost of this transportation.

18. It is understood that in some medical situations, the staff will need to contact the local emergency resources before the parent and/or another adult acting on the parent's behalf.

19. I understand that Edina Community Ed offers a summer school age child-care program to students entering Kindergarten through grade 6, and who, additionally, are not older than age 12. I understand eligibility to attend the program ends when the student begins 6th grade.

20. I am aware that my child's participation in the program may carry a risk of serious personal injury, serious illness, infection, death and property damage or loss. I expressly and voluntarily assume on behalf of my child and for myself all risk of injury, illness, infection, death and property damage or loss that may result from my child's participation in the program.

21. As consideration for my child being permitted to participate in the program, I hereby RELEASE AND DISCHARGE Edina Public Schools and Edina Community Ed, and all its officers, directors, employees, and agents ("The Released Parties") from liability for the injury, illness, infection, death, property damage or loss arising out of my child's participation in the program, but not including liability for any losses caused by the negligence or intentional wrongful acts of the released party.

22. I understand Community Ed programs are held in school buildings. If the school district closes due to bad weather, this affects all school related events, including Community Ed. I understand Community Ed does not offer refunds for cancellations due to weather.

23. I understand all district employees must notify Kids Club of their employment and provide a district email address in order to receive priority registration.

24. I understand that I should retain a copy of this contract for my records.
