The Whitey for Governor Campaign is proud to announce its proposal for a proper budget for the state of Dixie, guided by our uncompromising conservative values and our belief in the natural rights of man. We sought to reduce spending and taxes wherever possible, maintaining a balanced budget and ensuring that the state does not interfere with the lives of our citizens. Let us compare the two budgets and see why Whitey is the best option for Governor.

Democrat Budget

Looking through the existing budget, Whitey was able to find and cut over \$196Bn in waste and unnecessary expenditures, including the tens of trillions of dollars spent on regulatory agencies that make life more difficult for the average Dixian. Furthermore, the recreational marijuana and carbon taxes were mosquito taxes, not necessary to fund spending — they merely went to the budget surplus. **In other words, the Democrats tax Dixians when the revenue isn't needed.** Whitey opposes mosquito taxes and set taxes to the minimum necessary for spending needs to be met. Whitey understands that taxes exist only to raise revenue, not to cause pain for Dixians.

Another improvement of the Whitey budget over the Democrat budget is a better estimate of sales tax revenues, which keeps the budget balanced. The Democrat budget estimates that a sales tax of 6% can raise \$109Bn, when it can, in fact, raise only \$69Bn. This misestimation could lead to a serious shortfall and an increase in the state's debt, which already costs \$7Bn in interest.

Beyond these facts, the level of dependence on the federal government means that Dixie is currently more accountable to the feds than to Dixians — the Democrats managed to spend so much, despite their already high tax burden, that they need \$134Bn from Uncle Sam. If more than half the money is handed down by Uncle Sam, is Dixie being governed from Tallahassee or

from Washington? Whitey's spending reduction ends that, making sure that Dixie is accountable to Dixians, not to Zero and his communist cronies.

Whitey understands the need for efficiency in government programs, including in the corrections system. The official Dixie budget allocates \$7.5Bn for the Department of Corrections, but, looking at the facts, one finds that we can do better. Using the expertise from the old Louisiana and Alabama Departments of Corrections, we can reduce spending to \$6.4Bn, saving over a billion dollars and ensuring that our spending per prisoner does not bankrupt us. Louisiana and Alabama spent \$16k and \$14k per prisoner per annum, respectively, and by getting to those levels, the tax burden is reduced.
