Hours of Operation:

Programs will start promptly, so please plan to arrive at least 10 minutes before the start time to ensure punctuality. We will start on time!

What to Bring:

Please apply sunscreen and insect repellent prior to the start of the program. We suggest bringing a bag with extra spray and a water bottle. Jax Dragonfly Academy recommends wearing some type of athletic shoe or sneaker as most programs require walking. Mask requirements are in accordance with local regulations.

Medical Needs/Allergies:

Jax Dragonfly Academy Staff are not permitted to administer medication to program participants. In the event of a medical emergency, staff will administer first aid, CPR, and rescue in the best interest of the child. If a child is displaying cold or flu symptoms, they will not be permitted to attend the program at staff discretion.

Special Circumstances:

Parents and guardians are required to inform the Jax Dragonfly Academy in writing of any special circumstances which may affect the child's ability to participate fully and within the guidelines of acceptable behavior, including, but not limited to, any serious behavioral problems or special circumstances regarding psychological, medical, or physical conditions. These will be handled on a case by case basis.

Cancellation:

All programs will be held outside, so please prepare for the weather. Programs will still be held in rain, with the exception of lightning or other dangerous weather conditions. If a program is cancelled for weather, we will contact you via email 24+ hours in advance. If you need to cancel, you must do so at least 48 hours prior to the scheduled program to receive a credit to be used in a future program. Due to limited space in our classes, we will not be able to give credit or refunds less than 48 hours ahead of the class.
