§PRE-2: Glossary

"The Channel Family"

A membership higher than Internal Channel Membership (perks and requirements are stated in §C-1). This is intended to promote smaller channels.

Admin

A user with elevated powers (also known as administrative privileges) who has the abilities of kicking, banning and timing-out users in a certain space (e.g. Discord).

Appeal

A form sent by a user who has been banned stating what they did and why they think they should be unbanned, Admins and higher will review appeal submissions.

Ban

An administrative action where a user is removed from a space and in order to rejoin will be required to appeal, although not all bans are appealable.

Direct Collab

A piece of content (short, video or stream) which was planned between a user and The Bailz Channel which mentions The Bailz Channel (on collaborator's content) and the Collaborator (on The Bailz Channel's content).

Elevated "The Channel Family"

A membership higher than "The Channel Family" (perks and requirements are stated in §C-1). This is intended to promote smaller channels.

Frozen Membership

Where a membership retains whatever perks and privileges it has and has 2 months to become unfrozen before action is taken.

Instant Ban

A ban that occurs without consideration at the instant of a certain rule violation.

Internal Channel Member (ICM)

A User who has met the minimum requirements in §C-1 for this membership.

Kick

An administrative action where a user is removed from a space but is still able to rejoin.

Limited Internal Channel Member (LICM)

A User who has met the minimum requirements in §C-1 for this membership.

Manager

An elevated user with more powers (also known as administrative privileges) than an Admin, having the ability to almost fully modify the certain space.

Minimum Age

13, following Discord's Community Guidelines you must be 13 or older to use Discord.

Other Defined Channel

A channel which is not in a member of "The Channel Family "or in a Collaboration group which is owned by a user who is in "The Channel Family ", in which, The Bailz Channel is present.

Policies Head Admin

A person with the responsibility of allowing and denying the publishing of Policies after reviewing the edits. The Policies Head Admin can also elevate trial admins and admins without them meeting the requirements.

Timeout

An administrative action where a user loses the permission to interact and message for a certain period of time.

§A: Discord Rules

§A-1: General Rules

Abuse - Abuse to anyone will result in timeouts, kicks or bans.

At the instant that this occurs an admin is required to assess the severity of the incident and proceed with what they think is necessary.

(Abuse includes Harassment and Bullying of members.)

Anti-Pride / Anti-Furry (Homophobia, etc) - This one should be extremely easy to understand.

We do not allow any form of unequalness.

Instant Ban

Ban Evasion - When a user receives a Ban it should be appealed if possible. Unappealable bans are caused by repeated or serious violations of these rules. Users who use another account to bypass or "Evade" these Bans are violating this rule.

The table below shows the outcomes for if an Evading account is used while the offending account is still banned.

	Temporary Ban	Permanent Ban
Offending Account (initial offending account)	The initial offending account will receive a ban extension.	The initial account will remain banned.
Evading Accounts (owned by the offender).	Will be permanently banned.	Will be permanently banned. (if not banned already)

Discrimination - Discriminatory topics/behavior is prohibited.

Admins are required to proceed with kicks or bans

Doxing - Revealing people's private information, such as addresses, names, ages, schools, etc (which has not been shared publicly by the owner of the info) is not allowed. At the instant that this occurs an Admin is required to assess the severity of the incident and proceed with what they think is necessary. Do not use Timeouts in this case.

Heated Topics - Topics that are causing disruption or arguments will be shut down by Admins. Anyone who makes a continuation of it will receive a timeout. After a continuation of the topic, it is up to an Admin to choose what would be necessary to handle the situation.

Illegal Activities - Any form of breaking the law is absolutely condemned. The Bailz Channel is governed by the Australian (and other applicable) laws.

Instant Ban (Unappealable)

Language - Due to moderator limitations, communication is only to be done in English. Failure to do so may result in timeouts and continuation may result in further moderator action.

Links - Links are allowed under conditions. The following are not allowed. (1) sending links to malware or other dangerous sites, (2) sending links to sites that would break any of the policies stated here (e.g. a site condoning harassment)

Mini-modding - If anyone is breaking the rules please do not handle it yourself, Admins are on to look out for you.

What is Mini-modding?

Mini-modding is when there is an issue with a certain individual or group and a users will try to fix the issue on their own instead of informing a staff member (i.e. Admins).

NSFW / **Adult Content** - NSFW content such as invites, videos, images, inappropriate remarks (that users are not comfortable with), links and audio are strictly prohibited.

Instant Ban

Profiles - The Admins, Manager and Owner of the Discord Server reserve the right to moderate every part of Discord server member profiles (this includes, but is not limited to; display names, handles, server tags, bios, profile pictures, profile banners) while the user is still a member of the Discord Server, this applies to ever user, including moderators. If an inappropriate profile is found, the user will be issued a warning with what part of your profile was inappropriate, if moderators see no change in the next 48 hours a kick may be issued. Repeat offending will result in a ban.

Racism - Racial terms or abuse will not be tolerated.

Instant Ban

Spamming - Spamming in any way in any channel will result in the messages being automatically deleted by Dyno.

Although, in the instance of a user spamming and the messages not being automatically deleted by Dyno, an Admin is required to kick or ban the user

Terrorism/Sensitive Topics - Making jokes and/or inappropriate statements about terrorism attacks, wars and other sensitive topics are not acceptable.

Instant Ban

Threats (Reputation Based) - Threats to damage The Bailz Channel's, channels of "The Channel Family "and/or server members channels are prohibited.

Instant Ban

Toxicity - Making toxic remarks (e.g. no one cares, get a life/job, no one likes you, I didn't ask, etc) or being toxic will result in heavy timeouts followed by kicks and bans.

Admins are to proceed with a 1 day timeout, and proceed with a kick or ban if continued. * appealable unless this is the second ban caused by Toxicity.

Under Age - Anyone who is under the Minimum Age (defined in §PRE-2) is required to be kicked until they meet the required minimum age. If a user makes a statement, no matter if it was a joke or not will be kicked under the assumption of being under the Minimum Age. If the user rejoins while still under the minimum age they will be banned.

§A-2: Voice Channel Rules

- **Channel Hopping/Spam** Do not repeatedly join and leave voice channels, doing so will result in a timeout and multiple instances of it will result in higher action.
- **Loud Audio** Please make sure that Voice Activity is enabled when using voice channels, noise suppression (Krisp) is recommended.
- **Spamming Soundboards** Please do not spam the soundboards as it is disruptive. If continuous occurrences happen the soundboard will be disabled.
- **VC Capturing** If a server member's voice or face is found in a clip which was created without that member's permission, the moderators of the server reserve the right to ban you if you do not take down the content after request to by an Admin.

§C-2: Dispute Agreement

From July 29th 2024 at 12:00 PM (noon) AEST and onwards the Dispute Agreement has been part of the policies, anyone who is part of "The Channel Family" must follow this agreement.

The Dispute Agreement

Efficient: 23/06/2025 at 12:00 AM AEST

Whenever possible it is required for a member of "The Channel Family" to express an issue (here defined as a 'dispute') in private, whether it be via Email or via Discord.

Viewers are not affected by this agreement as this only applies to people in "The Channel Family".

In the case of a Collaborative group, if the owner is in "The Channel Family" they are responsible for the members of the group towards this policy.

EXAMPLE A: An individual who is in " The Channel Family " publicly expresses a 'dispute' they have with The Bailz Channel. This would result in a violation of this agreement, in which, punishment may occur.

EXAMPLE B: A 'other defined channel' or viewer of The Bailz Channel makes a 'dispute' publicly. This would result in either the issue being addressed in a post, requested of take down (using any methods available), or ignored. This cannot cause a violation of this agreement.

EXAMPLE C: An individual who is in a Collaboration group which is owned by a person who is in "The Channel Family "and, in which, The Bailz Channel is present, makes a 'dispute' publicly. If the dispute remains up after the owner of the collaboration group has been notified, the owner is at fault for the failure of the group's compliance. However, there is a possibility for a member of the group to be in failure of compliance.

§C-3: Collaboration Agreement

From the 1st of March 2025 at 12:00 AM (midnight) AEDT and onwards the Collaboration Agreement has been part of the policies, anyone who joins a collab agrees to this must follow this.

The Collaboration Agreement Efficient: --/--/2025 at --:- AM AEST

PART A: Requesting of Takedowns (Any Collab)

When you participate in a collaboration, you do not have the right for the collaboration to be taken down, unless:

- Your voice,
- Your face,
- A private username which you own, or
- A private avatar which you own

was captured in the collaboration.

Requesting a takedown of a collaboration for reasons such as:

- It contains a digital avatar, which is, or was able to be found publicly (and was released by the owner), or
- It contains a username, which is, or was able to be found publicly (and was released by the owner), and
- Other reasons alike these two

is not allowed.

EXAMPLE A: A collaborator requests for a piece of content, in which a digital avatar of theirs (for example Roblox Avatar), which was released by them to the public, is present, to be taken down. The Bailz Channel does NOT have to go ahead with this, as there is no violation of privacy.

EXAMPLE B: A collaborator requests for a piece of content, in which, a username of theirs (for example a Roblox username), which was released by them to the public, to be taken down. The Bailz Channel does NOT have to go ahead with this, as there is no violation of privacy.

EXAMPLE C: A collaborator requests for a piece of content, in which, a private avatar of theirs is present, to be taken down. The Bailz Channel will take down or remove parts of the video in which the private avatar was contained.

EXAMPLE D: A collaborator requests for a piece of content, in which, a private username of theirs is present, to be taken down. The Bailz Channel will take down or remove parts of the video in which the private usernames were contained.

EXAMPLE E: A collaborator requests for a piece of content, in which, their face or voice can be found, to be taken down. The Bailz Channel will take down or remove parts of the video in which the collaborator's voice/face was found.

PART B: Public Collaborations Robux

When you participate in a Public Collaboration, you will receive a payment in Robux within 60 days from the time the collaboration is finished.

If you choose to participate and join the collaboration: 25 R\$ or more (if stated)

If you choose to participate and not join in: 0 R\$

When you are banned you should receive a message from Dyno, use the appeal button to appeal.

§E: Logging Policy

How do we log?

@Dyno logs under settings.

What do we log?

Where is this logged?

#role-logs - when a role is deleted, created or given to a user.

#channel-logs - when a channel is deleted, created or the permissions of one are changed.

#message-logs - when a message is edited or deleted.

#join-logs - when a user joins or leaves.

#moderator-action-logs - when someone is banned, kicked or timed out.

#member-logs - when server nicknames are changed.

#emoji-logs - when an emoji is deleted, created or edited.

Why is this logged?

For usage of ban appeals, noting, reporting and server/member safety.


