# Alex

#### Board Member Statement of Purpose (Alex Palazzo)

I was nominated and elected to the board of directors at Hole in the Wall Theater in January of 2025, resulting in a short but fruitful five month tenure. Despite coming to HITW with the sole intention of being on its stage, I quickly found myself interested in being one of its leaders who brings that stage to life.

I believe at its core, theatre is a conversation. For 90 minutes (or 3 hours and 20 minutes if you do the Ferryman), theatre has the miraculous ability to make everyone in the room laugh, cry, and applaud despite what they might disagree upon outside its doors. And if they do disagree, theatre provides a platform for such conversations; theatre allows us to reflect on ourselves, or those we know in our lives, and challenges our existing views of them. Additionally, theatre builds community, and community builds theatre. Without the actors, the directors, the tech crew, the production team, or the patrons, theatre could not happen, and the aforementioned conversations could not take place. Each and every role in the theatre is a titular one, and what each of these roles can accomplish is greater when a diverse group of people is at the helm. Building a community with people from all walks of life allows the conversations on the stage to be open-minded, honest, and productive. Even the most obscure, absurdist, and farcical theatre is embedded in truth. Without that, theatre does not accurately reflect our world and is meaningless.

Cultivating an environment rooted in diversity and truth has never been more important than it is during this period in history. As a board member at Hole in the Wall I have two goals: to ensure that our theatre is a safe place for diversity and discussion, and to keep the lights on for new stories and new truths to unfold. And I believe in my first term as a board member I have worked towards achieving these goals.

Recently, I was asked to act as chair of the Conduct Committee, and am co-leading the effort to make sure our Code of Conduct is thoughtful and specific. In doing so, I am positive that I will have a positive impact on the environment and culture of the theatre. It is important to me that HITW take pride in its ability to reflect on itself as an organization. If there are areas where we can improve upon our values, and how those values are reflected in our expectations of our returning and new members, then I hope to be a part of that change.

In my first month as a board member, I was part of the vote to acquire a liquor license for the theatre. While a vote is a routine board member task, this vote provided an effective and creative means of increasing the theatre's revenue during the run of a show. Additionally, I strongly believe that in order to keep the lights on in the theatre, we need to keep the lights on in the theatre. In my next term as a board member, I hope to champion the move towards hosting events at the theatre more frequently. Outside of our main-stage shows, these events are currently scarce. Things like staged readings, happy hours, karaoke nights, and improv classes are a few examples of how we can both generate revenue for the theatre and also build our community.

I am also currently a member of the Mural Committee. It is my hope that this art will serve as an open invitation for new faces and creative forces. While we should always strive to uplift our current community at HITW, we need to work equally as hard to welcome newcomers to the theatre. Current people bring new people, and those new people bring newer people. Even a simple aesthetic change to let people know we are here will go a long way in enhancing our quality of work and seeing to it that our seats are always filled.

Lastly, I believe it takes a village to run a theatre, and my perspective alone cannot. Having open discussions at general meetings is an excellent way to have one's preconceived notions challenged, and familiarize oneself with the experiences of others (much like theatre itself). In my next term, I hope to collaborate with my fellow board members on how to run these meetings more efficiently, while also fostering a safe environment for people's voices to be heard. Along these lines, I hope to revitalize our DEI initiatives at the theatre so that these voices are heard. I believe that our DEI committee is perhaps our most important one yet it is also our least attended to. The existence of this committee with no action behind it is only performative inclusion, and we as an organization can do better. In my next term, I hope to become a member of the DEI committee and generate ideas for how to make our theatre more accessible and inclusive. Perhaps this involves things like monthly DEI nights, cultural showcases, or the inclusion of shows in our season that are DEI-centric. It goes without saying that in our current climate, these initiatives are important now more than ever.
