The specific scope, deliverables, timeline, and fees for any engagement are agreed in writing before work begins, either via a proposal, statement of work, or email confirmation. These Terms apply to all such engagements unless superseded by a separate written contract signed by both parties.

3. Free Tracking Audit

The Free Tracking Audit offered on this website is an initial 30-minute diagnostic call, provided at no cost and with no obligation. It is not a full audit and does not constitute a paid service engagement. I reserve the right to:

- Decline audit requests that fall outside my area of expertise
- Limit the number of free audits offered at any time
- Discontinue the free audit offer at any time without notice

Any recommendations made during a free audit call are high-level and informational only. They do not constitute a guarantee of results.

4. Fees and Payment

All fees for paid services are agreed in writing before work begins. Unless otherwise stated in a written agreement:

- A deposit of 50% of the agreed project fee is required before work commences

Delays caused by late access, late feedback, or incomplete information may affect project timelines. I am not liable for delays arising from your failure to meet these responsibilities.
