## Shrimp Mislabeling Exposed in Mobile Restaurant Market

### New DNA testing reveals gaps in compliance with Alabama's seafood labeling laws

**Mobile, AL – August 28, 2025** – In a city where shrimping fuels culture, cuisine, and coastal tourism, new DNA testing by SeaD Consulting has revealed potentially 1 in 4 Mobile restaurants misrepresent the shrimp they serve to customers.

Genetic testing, conducted with SeaD Consulting's patented Rapid ID Genetic Hi-Accuracy Test ([RIGHTTest™](#)), on one shrimp dish served at each of 44 randomly selected Mobile-area restaurants showed that while the majority were serving authentic wild-caught U.S. shrimp, nearly a quarter of sampled restaurants were not.

### Key Findings

- **77% (34/44)** restaurants sampled were confirmed to be serving wild-caught domestic/Gulf shrimp.
- **23% (10/44)** restaurants sampled served non-U.S. shrimp despite menu claims, staff assurances, or marketing.
- **Only 1 of 10 restaurants** serving imported shrimp in the sample survey displayed the required signage disclosing imported seafood items.

Under **Alabama's seafood labeling laws**, the roughly 25% of the restaurants tested serving imported shrimp should have posted signage disclosing imported shrimp. Instead, only one complied. The new law, which went into effect October 1, 2024, requires restaurants to disclose whether seafood is domestic or imported and whether it is wild-caught or farm-raised on the menu listing for dishes they sell or on "conspicuous signage" plainly visible to diners and patrons.

“With Mobile’s proud tradition of shrimping, our consumers deserve honesty,” said **Alabama Representative Chip Brown**. “This report shows why our state’s labeling laws matter — so diners know what’s on their plate, and our shrimpers aren’t undercut by misrepresentation.”

## Misrepresentation Findings

Of the restaurants not serving U.S. wild-caught shrimp:

- The majority described their shrimp as Gulf, local, or domestic either verbally or on menus.
- One implied Gulf or wild-caught sourcing through branding or marketing.

Because seafood mislabeling can occur at any point in the supply chain, some restaurants may genuinely believe they are serving domestic shrimp. However, testing what ultimately reaches the consumer's plate is the only way to verify authenticity.

"Shrimping is the cultural lifeblood and economic backbone of many Gulf and South Atlantic communities," said **Blake Price, Deputy Director of the Southern Shrimp Alliance**.

"SeaD's testing confirms most Mobile restaurants are supporting our shrimpers — but even one in four getting it wrong is too many. Diners should have confidence in the source of their food, and our shrimpers deserve a level playing field."

## Impact and Next Steps

Imported shrimp — often produced under unregulated or poorly regulated labor and environmental conditions — undermines Alabama's shrimp industry, damages consumer trust, and misleads diners who pay premium prices for what they believe is local seafood.

Follow-up testing is planned to measure compliance as Alabama's new seafood labeling law takes hold.
