A RESOLUTION For Safe And Expanded Work-study Opportunities For Fall 2020 In Light Of Covid-19

WHEREAS, according to the US Department of Education, "Federal Work-Study provides part-time jobs for undergraduate and graduate students with financial need, allowing them to earn money to help pay education expenses;" 1

WHEREAS, the average Federal work-study award is just under \$2000 and helps 15-20% of students nation-wide pay for college;²

WHEREAS, approximately 10-12% of Georgetown undergraduates are first-generation college students;³

WHEREAS, approximately 40% of Georgetown students receive some form of financial aid;⁴

WHEREAS, members of the Georgetown community, including those with a federal-work study, may be immuno-compromised and/or at increased risk from COVID-19;

WHEREAS, since the initial restrictions and stay-at-home orders, around 40 million jobless claims have been filed nation-wide;⁵

WHEREAS, several common Georgetown work-studies, like student guards and RHO positions, have substantially reduced hiring for the summer sessions;⁶

WHEREAS, on June 16, 2020, the University released several potential plans for the upcoming semester, including combinations of virtual and on-campus learning.

THEREFORE, be it RESOLVED by the Georgetown University Student Association Senate as follows:

- 1. DEMANDS THAT the students, especially those with a federal work-study, will still have access to employment during the COVID-19 pandemic;
- 2. CALLS UPON the University to offer digital/remote employment opportunities for the work-study;
- 3. FURTHER CALLS UPON the University to expand the number of remote job offerings to students:
- 4. ADVOCATES THAT a diverse option of shifts and hours are made available, with consideration to the students staying home in different time zones;
- 5. FURTHER DEMANDS THAT the University prioritizes the safety and wellbeing of those who rely on the federal work-study, but may feel unsafe to work in-person during the ongoing pandemic;
- 6. FURTHER ADVOCATES FOR additional hazard pay, when fitting, for those with on-campus work-studies during the upcoming fall semester;
- 7. FURTHER DEMANDS THAT students working in person on-campus are given adequate protection, including but not limited to masks, gloves, and hand sanitizer;
- 8. FURTHER CALLS UPON the University to clearly communicate, detail, and outline different job opportunities through email updates and/or frequent updates to the Student Employment Office website.
