#### President:

• Jim's work with the Canton road committee is done and their report is ready to be presented to the Canton Township board. The board will decide how to proceed but it was agreed a PASER study would be conducted on all township roads to determine what work is needed and to help prioritize that work. The committee recommended that an independent study be done as the only information provided to the committee was from township sources. They also recommended that no final decisions be made until the public has the opportunity to vote on them.

## Vice President

 The dog biscuit container and notebook/guestbook from the south park tiny library has been stolen several times. Stacey is going to work with Kyle to craft an email to go to the subdivision making them aware in an attempt to deter future thefts.

## Treasurer

111 more homes paid their dues in March with another 7 were paid this week. 21 homes are still outstanding and a second notice letter was sent to them. 4 homeowners immediately responded and will send their payments now. The

- current balance is now \$18,783.74 with more checks to be deposited this week. Jason moved to accept the Treasurer's report and Steve K seconded. Passed 7-0.
- 15 people included their emails with their payments so they can be added to the subdivision list and Karen will share those with Kyle.
- Karen received a letter from the current attorney handling our business. He and
  his wife are moving south within the next few months so we will need to find a
  new attorney. No one on the board had any recommendations so Karen will
  check with Lou Gianuzzi as he and his wife are realtors. Karen is going to pick up
  our files from the attorney within the next 30 days.

- A discussion was held regarding the wish list for this year's budget. Once quotes are obtained, items will be prioritized based on cost and importance. Items presented were:
  - Sealing or replace the south park path. Jason will get quotes for both options.
  - Additional trees for both parks, including ornamental trees near the two tiny libraries.
  - Frisbee golf posts.
  - o Gutters for the pavillion. Jason has a resource for this and will get a quote.
  - Grill for the pavillion similar to those in other public parks, charcoal grill cemented in the ground. Would only need to purchase, can be installed by HOA members.
  - Mulch for the play areas or possibly rubber mulch. Quotes will be obtained.
  - New playscape for north park.
  - 2 rose bushes in the Barchester island may need to be replaced.
