

Privacy Policy

Part I : Types of Data Collected

We automatically collect certain data about your interaction with the Apps ("Usage Data").

Usage Data may include data about how you download and use the App, including device data(model, manufacturer, language, IDFA, IDFV, GAID, screen resolution, etc.), data about your network connection(mac address, network type), and other data regarding your interaction with the App.

If you contact us, your email address, name and other information you provide will also be collected by us.

Part II : Third-Party SDKs

The App may contain SDKs or services provided by third parties. When you use these SDKs and third-party services, these third parties may collect your personal data. Such third parties are responsible for ensuring that any processing of personal data by them in providing services to you complies with applicable data protection laws. Right to restriction of processing (Article 18 GDPR)

Right to data portability (Article 20 GDPR)

Right to withdraw consent (Article 7(3) GDPR)

Right to object to certain data processing activities (Article 21 GDPR).

Right to complain to the data protection supervisory authority responsible for us.

Part VI: Kids' Privacy

We are committed to protecting the safety and privacy of young people's Internet use. We do not intentionally provide the App to teenagers under the age of 18 or collect their personal data. We believe that any teenager under the age of 18 should obtain the consent of their parents or guardians before using the App or providing us with personal data.

If you find that any teenager under the age of 18 is using the App without the consent of their service or guardian, please notify us immediately.

Part VII: Data Share

We will only share your data with third parties based on providing you with the various functions or services of the App, or based on fulfilling the obligations imposed on us by law.
